JDC, WAM Clarifies that social welfare organizations granted tax exempt (HSCR901) Requires social welfare organizations granted tax exempt status Status & under 501(c)(4) of the Internal Revenue Code that donate or contribute to noncandidate committees, engage in **Testimony** electioneering communications, or provide an endorsement for or against a candidate to register with the campaign spending commission and file organizational and financial reports. Effective 7/1/2060. (HD2) RELATING TO CITATIONS. JDC, WAM HB 1377, HD1 Creates an electronic citation program under the judiciary and (HSCR888) establishes an electronic citation surcharge. Repeals on 6/30/26. (HD1) Status &
