Increases the maximum fee for inpatient care services to five and one-half per cent. Increases the amount of time hospitals have to pay the hospital sustainability fee from thirty days to sixty days. Requires the department of health to establish a reorganization pilot project to reorganize the department of health behavioral health services administration; environmental health administration; general administration, including the office and the director of health; and health resources administration. Effective 7/1/2050. (SD1)	HTH, WAM
