<u>SB 56</u> <u>Status &</u> <u>Testimony</u>	RELATING TO REVENUE GENERATION. Increases the personal income tax rate and implements a rate recapture mechanism that phases out lower tax brackets for high earners for taxable years beginning after 12/31/2020. Increases the tax on capital gains. Increases the corporate income tax and establishes a single corporate income tax rate. From 7/1/2021 through 6/30/23, temporarily repeals certain general excise tax exemptions. Increases conveyance taxes for the sale of properties valued at \$1,000,000 or greater.	WAM
<u>SB 1349</u> Status & Testimony	RELATING TO CAPITAL IMPROVEMENT PROJECTS BENEFITING AGRICULTURE. Appropriates funds for capital improvement projects for agriculture.	WAM
