<u>HB 119, HD1</u> <u>(HSCR938)</u> <u>Status & Testimony</u>	RELATING TO THE ISSUANCE OF SPECIAL PURPOSE REVENUE BONDS TO ASSIST KAUNALEWA. Replaces E Ola Mau Na Leo O Kekaha with Kaunalewa as the entity authorized to receive special purpose revenue bonds issued to assist with the acquisition, remediation, and development of the old Kekaha Sugar Mill in Kekaha, Kauai, Hawaii. Effective 7/1/2050. (HD1)	WTL, WAM
<u>HB 863, HD2</u> <u>(HSCR863)</u> <u>Status & Testimony</u>	RELATING TO FORESTRY. Authorizes general obligation bonds for the forest stewardship program of the department of land and natural resources to build and expand facilities of the state tree nurseries. Effective 1/1/2050. (HD2)	WTL, WAM
<u>HB 1276, HD1</u> <u>(HSCR955)</u> <u>Status & Testimony</u>	RELATING TO STATE PARKS. Allows the board of land and natural resources to adopt, amend, or repeal administrative fee schedules for certain activities related to state parks through regular or special board meetings rather than through administrative rulemaking. Appropriates funds out of the state parks special fund to raise the expenditure ceiling of the special fund. Effective 1/1/2050. (HD1)	WTL, WAM
