

### **Senator English Looks Back at 2005 Session**

Progress in the areas of environmental regulation and the eradication of invasive species, a historic measure to ensure the dignity of patients at Kalaupapa, and a wide variety of Capital Improvement Projects for the 6<sup>th</sup> District were hallmarks of the 2005 Legislative Session for Sen. J. Kalani English. Sen. English, who represents Hana, East and Upcountry Maui, Moloka'i, Lana'i, and Kaho'olawe. In an interview the day after the May 5 adjournment of the session, Sen. English looked at recent accomplishments and future goals.

#### **Cruise Ship Standards**

For the first time, Hawaii will have a law on the books that sets standards for discharges of waste materials from commercial passenger vessels into the marine waters of the State. Sen. English said, "We started out with ambitious goals, and one of the most important was getting control of cruise ship discharge by bringing it under the rule of law." Up to now, cruise ship discharges in Hawaii have been governed by a Memorandum of Understanding that does not carry legal penalties. "The cruise ship industry is growing rapidly, and it has the potential to be a major industry in Hawaii," Sen. English says. "But we need to be able to assure people here that the environment will be protected as the industry grows. If we put in the right safeguards we can grow the industry and protect the environment." Cruise lines that currently operate in Hawaii have generally complied with the guidelines, Sen. English says, but "We have to have something in place that companies can choose to look at before they come here and say, 'Okay, we can live up to that.' Today there is first-class technology available to treat waste, and this legislation will encourage them to take advantage of it."

#### A "Delicate Balance"

"There is a delicate balance to be struck between tourism and the environment," Sen. English says. "It's not an either-or situation, the way I look at it; it's an all-encompassing, inclusive package. The environment is our economy. The main thing we sell – the basis of our tourism – is the culture and the environment, and that's the basis of the cruise ship industry. People come here because we have a spectacular environment to look at. We have a unique cultural experience – and if you don't protect that, you're actually hurting the economic engine that brings people here. Look at what happened to Waikiki a few years back when it was in decline. People didn't want to come there because it looked like everywhere else. It became a homogenized resort area, and Waikiki had to go through a

reinvention of itself to be unique again. So I don't draw a distinction between the environment and the economy. It's all one, and that's how I looked at all the legislation that we did this session. We cannot sacrifice either."

#### **Coqui Eradication**

The threat of invasive species is another key environmental concern. In a year when few environmental bills passed and funding was scarce. Sen. English was able to get a State appropriation for coqui frog eradication in Maui County. The species spreads rapidly, but Sen. English believes it can be stopped on Maui before it can become entrenched. "I think we have a great chance in Maui. It's a slim window;

it's \$100,000 out of a \$300,000 statewide allocation – but if you combine it with all the other efforts it will have a major impact. They could use this money to buy hydrated lime, or sprayers, and get into the valleys and get rid of these frogs. So while we didn't get as much money as I would have liked, this amount goes a long way to help."

#### **Affordable Housing**

One of the Capital Improvement Projects approved for this year is intended for affordable housing in Hana. Sen. English said, "I know for a fact just how acute the housing crisis

is. The original amount that I asked for was \$5.6 million. We were fortunate to get \$1.6 million in the State Budget to support a project in Hana. Hana Ranch has donated some land, and with the values of land, this donation is huge. I'm hoping that this money can be used to put in infrastructure to help lay the groundwork for affordable housing to be built. I'm hoping this attracts some non-profits and other philanthropic organizations to chip in and help to create a project that's viable. I think that people will be very satisfied with a modest home and a small plot of land that is their own. With this kind of positive development it creates great opportunities for

families who have been there for generations to continue to live in Hana."

"On the other side of it, I want to continue to support the subsistence economies in my district: Hana, Moloka'i, Lana'i -places where the productivity of people is honored, and the ability of people to raise their own food, gather their own food, and redistribute it among the community is not lost.""

#### The First Bill of Its Kind

Former Hansen's Disease patients at Kalaupapa continue to struggle against centuries-old prejudices, and a law to ensure that they will be treated with

dignity and respect is being hailed as one of the first of its kind anywhere. Sen. English introduced a measure that had been crafted through the efforts of Kalaupapa residents and former Rep. Sol Kaho'ohalahala that says, "the Legislature declares its intent to ensure that all residents at Kalaupapa are treated with dignity, respect, courtesy, and sensitivity." a historic measure by Disease advocacy

The bill is being called international Hansen's organizations. Anwei Law, International

Coordinator for IDEA, the International Association for Integration, Dignity, and Economic Advancement, said, "I don't think there is a law like this anywhere in the world. From my experience, this is the first of its kind. We all have inherent dignity. This is a legislative body requiring people to treat others with dignity."

Sen. English hopes the bill can set a precedent. "I hope organizations like IDEA can use this bill to go to other parts of the world, to governments that still isolate Hansen's Disease patients, and say 'This is what an enlightened society can do.""



As Chair of the Committee on Energy, Environment, and International Affairs and a member of five other committees, Sen. English has a wide range of issues cross his desk.

This year's State Budget includes more than \$20 million in Capital Improvement Project (CIP) funds for Sen. J. Kalani English's 6<sup>th</sup> District. The appropriations include essential funding for schools, health care facilities, agricultural projects, and highway and airport upgrades. Several of the appropriations listed below allow the State to qualify for federal matching funds.
