PRIME MINISTER OF JAPAN, SHINZO ABE VISITS HAWAI'I IN A HISTORIC VISIT

On December 26, Sen. J. Kalani English was invited to attend a reception with the Japanese Prime Minister, Shinzo Abe. Over one hundred dignitaries and invited guest filled the ball-room at the Hawai'i Convention Center to hear from the Japanese Prime Minister. He was in Hawai'i to join President Obama in acknowledging the 75th anniversary of the bombing of Pearl Harbor. Although former Japanese leaders have visited Pearl Habor in the past, Prime Minsiter Abe became the first to set foot on the Arizona Memorial.

Abe's visit was another chapter in the reconciliation between the United States and Japan and similarly mirrored President Obama's visit to the peace memorial in Hiroshima back in May. Following the devastating events of World War II, the two countries were able to forge one of the most enduring diplomatic relationships in recent history.

"The world needs the spirit of tolerance and the power of reconciliation now — and especially now," said Prime Minister Abe. "....people all around the world, will continue to remember Pearl Harbor as the symbol of reconciliation."

Sen. English, who is a graduate of the East-West Center's Institute of Culture and Communication understands the importance of these reconciliation efforts. Having previously worked with many leaders from Japan and across Asia, Sen. English is all too familiar with the events that led to the historic visit.

"The coming together of President Obama and Prime Minister Abe at Pearl Harbor was the

culmination of seventy-five years of diplomatic efforts towards reconciliation," said Sen. English. "Despite the tragic events of World War II, the United States and Japan have emerged from the ashes as close allies bounded together by aloha."

2016 INTERNATIONAL AUSTRONESIAN CONFERENCE

The Council of Indigenous Peoples of the Republic of China (Taiwan) has been holding the International Austronesian Conference since 2002. This year, Sen. English was invited as a presenter on the topic "The International Experience of State's Apologizing to Indigenous Peoples and Subsequent Actions." The theme of the 2016 Conference was Reconciliation, Coexistence and Sustainability: Articulating the Social-Ecological Wisdom of Austronesian Family." The Conference was held in Taipei, Taiwan from November 23-27.

The indigenous peoples in Taiwan are the inhabitants of the islands before the major Chinese immigration began in the 17th Century. They belong to the Austronesian peoples, the majority in Southeast Asia, Taiwan in the north, extending to Easter Island and reaches Madagascar in the eastern coast of Africa.

On August 1, 2016, President Tsai Ing-wen apologized to the indigenous peoples on behalf of the government for four centuries of mistreatment. The President stated that the indigenous peoples were the first inhabitants and throughout the course of history became displaced, foreign, and marginalized.

Pres. Tsai hopes that the apology is the beginning that will set Taiwan and all its people on the path towards reconciliation. She established an Indigenous Historical Justice and Transitional Justice Commission under her office and will personally work with the indigenous peoples to pursue historical justice. The Commission will serve as a mechanism for collective decision-making by

indigenous peoples.

Pres. Tsai believes that the duty for reconciliation lies with the government. Where modern laws and traditional cultures are at odds, the government will deliberate solutions. Under the principle of respecting

self-identity, relevant laws will be examined so that ethnic group identity will receive the rights and status it deserves. Further, the ideals of indigenous self-government will be realized step by step; 3 laws that are important to indigenous peoples will be deliberated by the legislature, the Indigenous Peoples Self-Government law, the Indigenous Peoples Land and Sea areas law, and the Indigenous Peoples Languages Development Law. More importantly, Pres. Tsai called for the entire society to come together, to know their history, land, and the many cultures of the ethnic peoples and work towards reconciliation and a shared existence and shared prosperity for a new future for Taiwan.

"The paper I presented at the Conference in Taiwan correlates to Pres. Tsai's Apology," said Sen. English. "The paper addresses the United States (US) Governments' reconciliation process in the aftermath of the 1993, "Apology Resolution" (US Public Law 103-150). In the twenty-two years that have passed, much still remains to be done by both the US and the Native Hawaiians in

the establishment of the ideals of self-governance."

During the trip, Sen. English also toured the Tangaanua community of the Kanakanavu peoples of central southern Taiwan. The issues that were important to this community were: post disaster reconstruction, government recognition of indigenous status and self-identification and cultural conservation.

DOT Public Information Meeting Regarding Emergency Work On Hāna Highway (Route 360)

On December 14, 2016, the Department of Transportation (DOT) held a public information meeting at Helene Hall to discuss matters relating to the work that is necessary to repair damage that Hāna Highway sustained during recent September storms.

Donald Smith, a Maintenance Engineer with the DOT provided an update on the work that is being done to improve conditions along Hāna Highway. Many of those who attended the meeting expressed concerns regarding the temporary remedy to the continual problems caused by severe weather that continue to impact Hāna Highway annually. Despite frsutration, community members expressed their appreciation to the DOT for their efforts.

"The Department of Transportation is looking for lasting solutions to curb the damage to the highway," said Sen. English. "While the processes may seem slow and at times an inconvenience, my staff and I remain dedicated to allocating the necessary funds to ensure that the Hāna Highway remains open, sound and in good repair."

57TH MEETING OF THE ASSOCIATION OF PACIFIC ISLAND LEGISLATURE BOARD OF DIRECTORS

This year, Sen. English, who previously served as President of Association of Pacific Island Legislatures (APIL) from 2008-2010 represented Hawai'i at the 57th Meeting of the APIL Board of Directors that was held on December 7-9, 2016 in Weno, Chuuk-Federated States of Micronesia (FSM). He was among dozens of legislators who gathered for the three-day event.

The event began with an opening ceremony, hosted by the Chuuk State Legislature. Governor Johnson S. Elimo and Speaker Innocente I. Oneisom of the Chuuk State Legislature opened the ceremony by welcoming APIL delegates to Weno, Chuuk-FSM, the country's largest city. Outgoing APIL President, Kenneth Keidi of the Republic of the Marshall Islands also provided opening remarks.

Sen. English officiated the swearing-in-ceremony as new officers took their oath of office for the 2016/2017 term. The new officers include:

- President: Vice Speake Robert I. Taulung (Kosrae, FSM)
- Vice President: Speaker Fernando Scaliem (Pohnpei, FSM)
- Secretary: Senator Nelson Stephen (Chuuk, FSM)
- Treasurer: Vice Speaker Joseph Deleon Guerrero (Northern Marianas Commonwealth)

During the three-day event, Sen. English attended various presentations that were hosted by APIL Subsidiaries and Partners. These presentations were centered around the issues of economic development, human services, innovation and conservation.

"These presentations provided excellent insight on issues, such as economic devel-



opment and marine conservation, that are important to Hawai'i," said Sen. English. "The presentations were very informative and helped educate APIL delegates on what is being done across the Pacific to address these important issues."

Thirteen resolutions were introduced by member governments of APIL to address many issues that are impacting the Pacific. In matters of health and human services, Senator Jerry Fagolimul of the FSM State of Yap introduced a resolution (57-BOD-03) relating to the feasibility of developing a New Pacific Regional Airline. The resolution explains that a shortage in the visitation of international flights, in the States of Kosrae and Yap are "depressing the economic development of the region and endangering the lives and welfare" of its people, especially in times of medical emergencies.

The matter of workforce development was another important issue that was also addressed, via resolution 57-BOD-07. Delegate Yutaka Gibbons Jr. of the Republic of Palau introduced this resolution to address the work restrictions that prevent many Pacific Islanders from easily traveling to islands that are experiencing a rapid development in tourism. The resolution calls on members of APIL to join together in a concerted and coordinated effort to recruit, help train and ease the travel and work restrictions for skilled groups of men and women from across the Pacific. The hope is that by doing

so, Pacific Islands will meet the expanding demands of the tourism industry and begin to experience prosperous economic development.

The three-day event culminated with the announcement of the APIL 36th General Assembly to be held in June 2017 on Christmas (Kirimati) Island, Republic of Kiribati. A farewell reception hosted by the Chuuk State Legislature was held at the Blue Lagoon Resort, where delegations offered closing remarks and presentation of gifts.

"APIL is a great venue for Pacific leader to convene, learn and collaborate with one another about various issues that affect the Pacific," said Sen. English. "For us as people of the Pacific, we are both genealogically and physically connected through ka moana o Kanaloa (the ocean). It is through this connection, that we will be able to come together, find solutions to current issues and further advance our people into a more prosperous future."

The Association of Pacific Island Legislatures (APIL) was formed in 1981 and is comprised of legislative representatives from 12 Pacific island governments. APIL meets regularly to consider matters in areas where regional cooperation, coordination, exchange and assistance may help governments achieve their goals through collective action.

Sen. English was one of a select group of legislative leaders invited to attend the SGAC Annual Conference that was held in Dana Point, California from November 19-22. The conference was presented by the SCAC Foundation, in cooperation with the National Conference of State Legislatures (NCSL) and The Council of State Governments (CSG).

The purpose of the SGAC Foundation is to conduct research, sponsor conferences and seminars and promote other educational activities related to State Governments.

"States Leading the Wave of Change" was the theme for this year's conference. The theme reflects the States' role regarding critical issues facing the nation such as: Tax incentives versus Comprehensive reform; Workforce development and investing in America; State-run retirement savings programs; US foreign relations; Alzheimer's – A looming public health crisis; The opioid epidemic; and The Toxic Substances Control Act (TSCA) reform legislation.

"The conference provided a unique opportunity to build relationships with other legislative leaders," said Sen. English. "These relationships help build a national framework that we can tap into to help resolve some of the issues we face at home."
