

Hot Topics: economy & education

Things are off to a fast pace here at the Capitol. Hearings are being held daily to tackle some tough issues. First, in the Senate Ways and Means Committee, we have completed our informational briefings with each state department. The directors came before us to outline their respective department's budget condition and explain how cost cutting measures have affected their core missions and efficiency.

One of the highest priorities this year is education. As such, we have heard several bills intended to address the unconscionable "furlough Fridays". In my opinion, we need to strive to exceed expectations rather than just return to the status quo of how it was before furloughs came to our state.

Here are just a few of the current proposals:

SB 2470 - RELATION TO EDUCATION.

Requires all public schools, including charter schools, to implement a minimum of two hundred days of classroom instruction per school year. Prohibits any collective bargaining agreement under chapter 89, Hawaii Revised Statutes, from containing provisions that would shorten the school year for public school employees to less than two hundred days of classroom instruction per school year.

SB 2436 - RELATING TO EDUCATION.

Makes an emergency appropriation from the Hawaii hurricane relief fund and the emergency and budget reserve fund to restore as many instructional days during the 2009-2010 school year as possible.

SB 2437 - RELATING TO THE FUNDING OF THE STATE PROGRAMS.

Makes an appropriation from the Hawaii hurricane relief, emergency and budget reserve, and federal troubled asset relief program funds to restore as many instructional days until January 1, 2011, of the 2010-11 school year as possible. Increases the general excise tax by one per cent to restore as many instructional days beginning on January 1, 2011, of the 2010-11 school year as possible. Increases all state standard income tax deductions and provides tax credits for the purchase of food items. Appropriates additional general excise tax revenues.
