LEGISLATIVE REPORT

It was a widely held belief that this past Legislative Session would be a difficult one. And that belief was well founded. Beginning with the scaled back opening, the atmosphere was set to get straight to business from day one. The number one priority - the budget; which tied directly to another concern of preeminence – education.

The work on the year-two supplemental budget was arduous. We heard from the administration, each of the various state agencies, from non-profits, from business owners, from furlough-affected employees, and every other group you could imagine. Some advocated an increase in the GET while others rejected that notion summarily. What ultimately occurred was a more staid and balanced approach which incorporated a downsizing in government coupled with some income generating measures – no GET increase. We also passed some major pieces to strengthen and improve our education system and provide a path to eliminating the disastrous furloughs of our public school students. Here is a sampling of some of the major legislation. A comprehensive wrap-up edition of the newsletter will be provided at next month's meeting.

EDUCATION:

- SB2124 RESTORATION OF INSTRUCTION DAYS Appropriates funds (\$67 million) from the Hawaii Hurricane Relief Fund to restore instructional days for the 2010-2011 school year; moneys shall only be released upon completion of negotiations of relevant parties.
- HB2376 BOARD OF EDUCATION -Amends the Hawaii Constitution to change the Board of Education to a board appointed by the Governor, with the advice and consent of the Senate, as provided by law (put to voters).
- SB2486 MINIMUM INSTRUCTION DAYS/HOURS Requires the phasing in of implementation of a certain number of student instructional hours at public schools (minimum 180 school days).
- <u>HB2377</u> Board of Education;
 Appointment; Selection Advisory
 Council Requires the members of the Board of Education to be nominated and, with the advice and consent of the Senate, appointed by the Governor from lists of qualified candidates presented to the Governor by the Board of Education Selection Advisory Council.

BUDGET:

- HB2200 STATE BUDGET To adjust and request appropriations for Fiscal Biennium '09-'11 funding requirements for operations and capital improvement projects.
- SB2469 EMERGENCY AND BUDGET RESERVE FUND Appropriates moneys (\$24,516,636) from the emergency and budget reserve fund to maintain levels of programs for education, human services and health.
- SCR18 INVESTIGATION/LEGAL ACTION/AUCTION RATE SECURITIES –

Establishing a joint legislative investigating committee to oversee the investigation of the Dept. of Budget and Finance's handling of the State's investment in student loan auction rate securities.

- <u>HB1948</u> INCOME TAX REFUND -Requires the Dept. of Taxation to provide refunds to taxpayers within 90 days of the filing of the return
- HB2421 FOOD & ENERGY SECURITY: Establishes initiatives to promote economic development for local food and energy businesses, and provides credit of the general fund
