As a member of the Senate Standing Committee on Education and Housing (EDH), as well as my role of dad and Papa, I want to convey my congratulations to the DOE on their success with the Obama administration's Race to the Top grant.

Hawaii has been named a "RACE TO THE TOP" grant recipient as of August 24th. We will receive \$75 million in federal funding to implement comprehensive initiatives to reform our state's public education system in order to improve student achievement. Not only have we demonstrated a desire to reform but the capacity to do so successfully.

I was extremely impressed by the presentation of plans for transformation of our state's education system when the panelists came to speak to a joint Senate/House Education Committee informational briefing on August 17th. Maika'i loa! I commend the efforts of all the people who worked diligently to make this goal a reality. We will one day have a highly effective teacher in every classroom and a highly effective principal in every school. Although this grant is a momentous step forward for the public education system in Hawai'i, we should by no means let this be our last major achievement. Let us continue to work together to better improve our beautiful Hawai'i nei.

LEGISLATIVE URBAN CAUCUS

During our August Legislative Urban Caucus meeting we discussed solutions to address our homeless population. One model that is very intriguing comes from King County (Seattle), WA. I recently spoke to Bill Block, the Executive Director, to learn more about their current initiatives. They have created a 10-Year Plan and Committee to End Homelessness. The Governing board is comprised of both public and private leaders which creates greater accountability. While building new housing is desired, it is by no means the only option. Following a blueprint that focuses on current rental inventory, with a landlord-liaison program that would encourage more units become available to those who may be "economically homeless" we can put people in homes more rapidly. These are just a few ideas. We will continue to explore as solutions building up to the 2011 Legislative Session.

Chief Justice's nominee:


