Responsibilities

Responsibilities at the University of Hawai'i evolved over 27 years. From the mid-1980s on, served as the academic planning and policy officer for the ten-campus University of Hawai'i system, which encompasses all of public higher education in Hawai'i and includes the graduate research campus, two baccalaureate campuses, seven community colleges, and distance learning centers.

Executive responsibilities spanned four major functional areas: (1) managing the long-range planning and strategic planning processes; (2) coordinating analysis and development of both executive and Board of Regents policy; (3) overseeing the University system-wide institutional research function; and (4) providing overall coordination of policy and support for system transfer and articulation matters. System coordination of distance learning plans, policies, and master scheduling (early 1990s through mid-2002). Responsible for oversight of system management of information systems and information technology and distance education (1987 to 1993).

Chaired the System Academic Affairs Council; reviewed academic program matters requiring action by the President or Board and prepared executive and Board policies on academic issues; handled liaison with the All Campus Council of Faculty Senate Chairs; served as overall liaison with the Western Interstate Commission on Higher Education (WICHE) and the State Higher Education Executive Officers (SHEEO).

Led collaborative efforts such as: preparing and obtaining Board approval of University mission statements, system Strategic Plans, and tuition schedules for all campuses and various professional programs; developing the policy base for University Centers on neighbor islands; publishing benchmarks/performance indicators; reorganizing the management of the University's information technology and computing resources; negotiating the provisions of a state law enabling the University to retain its tuition revenue; establishing a system policy governing the general education requirement across campuses; updating a variety of Board academic policies; and preparing system accreditation documents.
