I volunteered for the National Weather Service for six months and was then granted an entry level job, as promised. I retired after 25 years of service with them. I know the administration went to a great extent to accommodate me. My job title was Supply Technician.

I was a member in good standing of USAF Tradewinds NCO Club for 29 years. I'm still a member of Amnesty International, after more than 30 years. Some people made it clear to me that they oppose my stance regarding human rights. I know human rights are more inclusive than civil rights.

I volunteered for CrimesSoppers Honolulu, Inc. every Saturday morning for 15 years, I left them after my [REDACTED] birthday.

Someone in my family said my health went downhill ever since I was a passenger in a Chevrolet Corvair accident at age 15. I'm [REDACTED] and mobility impaired.

I'm a devout Christian and I support the rights of all people. My current religious membership is with Church of the Crossroads, United Church of Christ.

I've lived in senior citizen/disability housing since the winter of 1980.

I'm currently an Air Force Association volunteer and I have a Gold Pass which gives me access to Joint Base Pearl Harbor Hickam.

I'm seeing a local psychiatrist whose professional skills are kind and accommodating.

I had a second epidural recently. I'm in constant touch with four members of the Clergy.

I don't approve of illegal drug use and I don't want young people imprisoned for experimenting with marijuana.
