#### LIMITED BIOGRAPHY

### ROBERT A. HONG, M.D., F.A.C.C., F.H.R.S.

Dr. Robert Hong was born and raised in Honolulu, Hawaii. He completed his undergraduate education at Stanford University in 1977 and received his doctorate in Medicine at the University of California – San Francisco in 1981. His postgraduate training in Internal Medicine was performed at the Beth Israel Hospital in Boston Massachusetts under his Chief of Medicine, Dr. Eugene Braunwald. Dr. Hong completed a fellowship in Adult Cardiovascular Diseases at the Los Angeles County – University of Southern California Medical Center in 1987 while under the supervision of Dr. Shahbudin Rahimtoola.

Dr. Hong entered the private practice of Cardiovascular Medicine in 1987 and has maintained his practice in Honolulu, Hawaii since 1987. He was appointed Assistant Clinical Professor at the John A. Burns School of Medicine (JABSOM), University of Hawaii in 1989. While his primary emphasis had been in the practice of clinical medicine, Dr. Hong has changed this to focus on medical education and administration. Dr. Hong was appointed as Associate Professor in Medicine in 2003 and as the Chief of the Division of Cardiology for JABSOM that same year. He was promoted to Professor in Medicine in 2014. Dr. Hong changed the scope of his practice in May 2009 and was employed by the Queen's Medical Center. He served as the medical director of the Queen's Heart Physician Practice between 2009-2016. The Queen's Heart Physician Practice consisted of 16 cardiologists who provided service to the Queen's Medical Centers and served as key clinical faculty members for a fellowship in Cardiovascular Disease. He passed on this position but resumed an administrative role as the medical director of the Cardiovascular Invasive and Interventional Services group in 2018 through 2019. Dr. Hong left employment at the Queen's Medical Center in 2019 and joined the University of Hawaii Faculty Practice program in 2019. He serves as the Vice Chair for Clinical Affairs of the Department of Medicine.

Dr. Hong created the first ACGME-certified postgraduate fellowship in Cardiovascular Disease in the state of Hawaii in 2010 and was appointed program director that year. He received the Peter C.P. Char Excellence in Education, Program Director's Award in 2013 and 2016. This award is given to a single program director each year that has been recognized by their trainees for excellence in teaching and administration. There are over 12 different residencies and fellowships supported by JABSOM who give input into this award. In his role as Program Director, Dr. Hong served on a task force of American College of Cardiology Program Directors section addressing fostering diversity in training and served on an American College of Cardiology Program Directors Committee addressing increasing diversity in Cardiovascular training programs. He stepped down from his program directorship in 2019.

With the generous contribution of Ms. Judith Dion Pyle, Dr. Hong assisted in the establishment of an endowed chaired professorship at the John A. Burns School of Medicine directed at education in Cardiovascular Disease.

Dr. Hong is certified by the American Board of Internal Medicine in: Internal Medicine, Cardiovascular Disease, Clinical Cardiac Electrophysiology and Advanced Heart Failure and Transplant Cardiology. He has also received certification in Transplantation Cardiology by the United Network for Organ Sharing.

Dr. Hong has served in a variety of medical administrative positions including: Chief of Staff, Vice Chief of Staff, and Chief of the Department of Cardiovascular Disease and the Division of Cardiology at the Queen's Medical Center. The Queen's Medical Center is the largest health care facility in the state of Hawaii with staff membership of approximately 1250 physicians. He has also served as the transplant cardiologist for St. Francis Medical Center/Hawaii Medical Center-East between 1988-2008.

Dr. Hong's professional memberships include: the American College of Cardiology, the Heart Rhythm Society, and the International Society for Heart and Lung Transplantation. He has served as the American College of Cardiology Governor for Hawaii and on the Emergency Care Committee for the American College of Cardiology. He is a Fellow of the American College of Cardiology and the Heart Rhythm Society.

Dr. Hong has been active in Medical Education and has received several excellences in teaching awards from the JABSOM.

Dr. Hong's publications include 36 scientific articles in peer-reviewed journals and 1 textbook chapter. Key publications include the first national publication describing the use of smokable methamphetamine and cardiomyopathy and the first description of left atrial esophageal fistulas related to the catheter-based treatment of atrial fibrillation.
