During the last 5 months, I have witnessed our staff working at a relentless pace to quickly serve our residents in need. We have dispersed millions of dollars in funds throughout the state for food assistance, health care coverage, childcare assistance, and more, at a rate that we have never seen within DHS. I credit our staff and employees who come to work every day with a sense of commitment to their community. It is not easy work and it often goes unnoticed.

I have served in my various roles within DHS according to my core values: respect, dignity for others, and a strong work ethic. I appreciate the opportunity to serve in this role and am committed to consistently working towards our residents' self-sufficiency and well-being, so they can access the resources they need to live in safety and dignity. I look forward to continuing my collaborative and consensus-based approach to leading this department and appreciate your favorable consideration.

Thank you for allowing me to submit testimony in SUPPORT of GM 503 o confirm Catherine Betts.

I have known Catherine Betts for about a decade. I can say with confidence that she combines the best attributes of a public servant and leader. She efficiently and knowledgeably carries out her duties with competence. And competence cannot be undervalued. Moreover, she cares deeply for the welfare of the clients who fall in the jurisdiction of the Department of Human Services and her work reflects the compassion she has for those that suffering from abuse, poverty and in serious need of official intervention and assistance.

In 2011, when the commissioners of the Hawaii State Commission on the Status of Women interviewed for the Executive Director position, it was Betts' background in law, professionalism, and our confidence in her leadership that dictated our selection. She was a Deputy Attorney General with the State Attorney General where she represented DHS litigating complex child abuse and negligent cases. She was a law clerk in the First Circuit Court preparing briefs for Mental Health Court, Adult Drug Court. When she identified indigent and immigrant victims of violence she referred them to pro bobo legal service. When victims didn't know who to call and ended up calling the Commission, they found a sympathetic ear and good advice. I recall Betts telling us about a woman in the Coast Guard whose commander was demanding sexual relationship.

It wasn't surprising that when the DHS Director stepped down, she became the acting director, then appointed to complete the term of the Director of DHS. Her accomplishments deserve another term as Director.

I have known Ms. Betts for nearly eighteen years, and she has always been a champion for traditionally underserved communities by fighting for equality and by ensuring access to resources for all people to achieve lives of meaning and abundance. This is an especially challenging undertaking, especially during today's pandemic and resulting economic crisis.

As the Legal Director of the Medical-Legal Partnership for Children in Hawai'i, I have worked for over a decade providing direct legal services and systemic advocacy for Hawai'i's low-income, immigrant, and under-resourced families in Kalihi Valley and across the state. Many of our clients are part of the vast "working poor" who are eligible for financial and health benefits provided by the state of Hawai'i.

Under Ms. Betts' leadership, both as Director and as Deputy Director, the Department of Human Services has been responsive to the needs of families, and the DHS staff is quick to address any problems raised by advocates. For example, during the pandemic, problems with language access and presumptive disqualifications from benefits were sadly the norm with many state agencies. In contrast, DHS took immediate steps to protect vulnerable families, including reducing administrative lapses to SNAP and Med-QUEST benefits, expanding childcare assistance, maintaining essential services for homeless individuals and people with disabilities, and continuing to provide language access to recipients. Most recently, Director Betts and her Med-QUEST administrators responded quickly to federal inclusion of Micronesian recipients (legally residing under the Compact of Free Association) for Medicaid, becoming the first state to fully update its online system to ensure compliance and accessibility. As an attorney and advocate, I witness every day the significant and immediate impact of these actions to prevent homelessness, promote resiliency, and save lives.
