Testimony in Support of Daphne Barbee – Wooten

Good afternoon, Chair Rhodes and Vice Chair Keohokalole,

I am Jeanne Schultz Afuvai, a citizen from District 24 and I am testifying in support of Daphne Barbee-Wooten as the gubernatorial nominee to the Board of Registration.

I have known Daphne for over 30 years. We first met when Daphne was a young attorney and I was in Governor Waihee's administration. We had several connections. We were both originally from Wisconsin, alums of the University of Wisconsin – Madison and passionate about civil rights and social justice. And, we had both transplanted our roots into the 'aina of Hawaii.

Daphne's father, Lloyd Barbee was an Assemblyman and civil rights leader in Wisconsin. Mr. Barbee was the seminal figure behind much of the progressive legislation in Wisconsin during the 60s and he finally got the Milwaukee Public Schools integrated in the 1970s. He lived the Wisconsin motto, FORWARD.

This is important to know because Daphne has the same passion, commitment and dedication for the people of Hawaii. During the last 30 years, she has personally helped my family in several moments of crisis. My Hawaii family is Polynesian and we have faced first-hand the vagaries of justice. Daphne never gives up, never. Her mission for my family and for every Hawaii family is that the justice system works for everyone. And that begins with maintaining and expanding voting rights for all eligible people.

Our democracy is so very fragile, as we have seen over the last four years and specifically, after the 2020 elections. I have always said that every state needs Stacey Abrams. Well, we have our Stacey Abrams and her name is Daphne Barbee-Wooten.

We need Daphne on the Board of Registration now, more than ever.
