Dear State Rehabilitation Council Committee members:

I am writing this letter on behalf of Victoria Kennedy, a leading advocate in Hawaii for people who are blind or visually impaired. I understand she has been nominated by the governor to be a member of the State Rehabilitation Council. That is a very wise choice, and I support her nomination whole-heartedly.

Her resume speaks for itself, but from my perspective, I also have worked closely with Victoria during the past few years on an international research project, founded at the University of Hawaii at Manoa, that is breaking much new ground around the world in the field of media accessibility. In short, this project, the UniDescription Project (<u>www.unidescription.org</u>) helps public places, such as U.S. National Park Service sites, become more accessible through Audio Description. Audio Description is the remediation of visual media into audible media, primarily for the benefit of people who are blind or low-vision.

For Vickie's part, she has been involved in multiple field experiments with me and two major international workshops, called "Descriptathons," serving as a team member with national parks, as a judge of Audio Description, and as an expert audience member of Audio Description.

During these workshops, we help to train professional interpreters around the U.S. and Canada to create better Audio Description, and they also create audio products during these events that are shared with the general public. In short, Vickie has helped these collaborators to learn about Audio Description, to practice Audio Description, and to produce Audio Description for the general public at some of the highest levels of public discourse (shared at both U.S. National Park Service and Parks Canada sites).

Throughout my interactions with her, Vickie has proven to be extremely engaged in the world, especially about learning how to better describe imagery for public audiences. In these settings, she consistently displayed kindness for others, a rigorous pursuit of her work, a multicultural sensibility to her environment, and a strong ethical backbone.

So, in short, her potential to do even more public good is very high, and I'm hopeful this position will help her to continue to advocate for people who need more-accessible media to participate in everyday government activities, a taken-for-granted sort of access that needs dire attention in the state of Hawaii. In short, I believe she would be an excellent member of the State Rehabilitation Council.
