I am honored to appear before you and be considered for Board Member of the Hawaii Paroling Authority. I would like to thank Governor Ige for his trust and confidence in making this nomination.

I have spent over 30 years in community corrections. My entire career has been dedicated to transitioning incarcerated individuals as they return to life our community. I worked at a local halfway house and served as a parole officer with the Hawaii Paroling Authority. The majority of my career was with the U.S. Probation Office as a probation officer, supervisor, and assistant deputy chief. I retired from U.S. Probation on June 30, 2020 after 28 years of service. I have not found a better way to come out of retirement than to continue my community corrections work with the Hawaii Paroling Authority.

I believe in the mission of the Hawaii Paroling Authority. I have the knowledge base and skill set to make critical decisions to grant parole and set minimum imprisonment terms. I am prepared to engage in the challenge to preserve public safety and facilitate opportunities for parolees to improve their lives as they return to our community.

To that end, I have a working knowledge of the principles and strategies of Evidence Based Practices (EBP) that research proves are effective to reduce recidivism. In my experience, the best supervision outcomes are achieved when an offender's risk and needs, and their criminogenic factors (such as Alcohol/Drugs; Education/Employment; Antisocial peers) are addressed and no longer a barrier to a successful reintegration.

I bring to the Hawaii Paroling Authority a retrospective and prospective knowledge base of effective and ineffective supervision strategies. Early in my career I worked in a traditional supervision model of enforcement and compliance without Evidence Based Practices. Page 2 GM607 February 8, 2021

As I have learned, supervision outcomes from a traditional model are less favorable than outcomes produced when using Evidence Based Practices. For nearly the last third of my 28-year career, I assisted in operationalizing an Evidence Based Practices model. The transition was an epic undertaking that brought significant change to the philosophy and culture of the U.S. Probation Office.

One of my goals as a Board Member is to foster the use of Evidence Based Practices to enhance the continuity of release preparation and reentry services. I pledge to use my knowledge base and experience in my decision making. I am committed to making significant contributions to protect the community and facilitate opportunities for sustained change.

I look forward to working collaboratively with the Paroling Authority Chair and Board Members, and Department of Public Safety to meet the needs and challenges of the department. I will serve with integrity, loyalty, and dedication to the mission. I have no personal conflicts of interests that would hinder serving as a Board Member. Thank you for your consideration. DAVID Y.
