(1) Why do you wish to be a member of the Hawai'i Medical Board?

Becoming a member of the Hawai'i Medical Board would provide a most valuable means by which I could make an uncompensated contribution to the people of the State of Hawai'i. It would be an honor and I would appreciate the opportunity to use my life experience, professional experience and educational background to help positively affect the lives of people that require and utilize the services of physicians (and other providers) within the multiple and varied health care delivery systems of Hawai'i. The Hawai'i Medical Board is an essential body and of the highest importance to the population of the state (ensuring patient safety) and the medical profession (ensuring utilization and promotion of best practices). I would like to be part of that mission.

(2) What do you perceive are the roles and responsibilities of a member of the Hawai'i Medical Board?

My understanding of the roles and responsibilities of the members of the Board is that there are many and they are important. Largely, the Board accepts, reviews, and renders decisions on applicants for licensure (or re-licensure) as physicians (M.D.s, D.O.s and others). The Board also reviews concerns brought forth by members of the public regarding individual clinicians. The Board may have to make recommendations for sanction against practitioners who hurt or injure their patients/clients or are perceived to have acted in an unprofessional manner. Additionally, the Board, at its bi-monthly meetings, responds to industry and public concerns about technological and practice-based developments within the practice of medicine. The Board also communicates with specialty organizations that have an interest in health care delivery and determines whether proposals or desires on the part of those entities should be supported and forwarded to state lawmakers and/or those who develop public policy.

(3) Given your understanding of the roles and responsibilities of a Hawai'i Medical Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

I have lived in the State of Hawai'i for 53 years and have a good understanding of public need in the area of healthcare. I have worked in under-graduate and post-graduate medical education since 1977 and despite not being a practitioner I have a very good understanding of clinical health care and health care delivery systems. My role as a residency program administrator (for the surgical, orthopaedic and surgical critical care training programs with the University of Hawai'i John A. Burns School of Medicine/Hawai'i Residency Programs, Inc. [2007-2020]) contributes to my being highly functional in understanding healthcare environments and practitioners. I feel that I have an excellent understanding of the healthcare paradigm from physicians and other clinical providers through the level of patient, including the underserved patient. I have dealt with a good number of matters that were relevant to professionalism, disciplinary action, and licensure. I served on the Board of Speech Pathology and Audiology from June 2014 through June 2020. For the last 12 months of the second term, I served as Vice-Chair of that Board. I have a solid understanding of how the Boards function and the roles of the participants (Board members and DCCA personnel).

(4) What do you hope to accomplish during your term of service?

I would hope to help maintain the high level of service and activity currently provided by

the Hawai'i Medical Board. As a public member I would provide a perspective, based upon my unique experience, different from that of the physician or surgeon members.

(5) Name three qualities that best describe you and how these qualities will benefit the Hawai'i Medical Board.

- 1. Willing and Eager to Serve I am a hardworking individual and my work output and quality largely define who I am as a person. I am able to successfully navigate through familiar and less-familiar territory – I consider myself a pragmatist and am able to get the job done. I retired from my position as Program Administrator for the Surgical, Orthopaedic and Surgical Critical care training programs on September 15, 2020. This would provide me with more than adequate time to perform the functions required as a member of the Hawai'i Medical Board.
- 2. Competent and Inquisitive I am of above average intelligence and have received a good education (both at James Campbell High School and the University of Hawai'i). I pride myself on being admired for my work quality and my work ethic.
- 3. Honesty and Integrity My honesty and integrity supersede all other qualities and characteristics I possess.
- (6) Name a previous experience you've had that will be beneficial as a Hawai'i Medical Board member.

My professional role as a Residency Program Administrator and my many years in healthcare education would be the most valuable contributors to success as member of the Hawai'i Medical Board. My post-graduate training is in Education. I have a Master of Education from the University of Hawai'i which provided the training to observe and absorb from different viewpoints and to see things from a systems perspective. On the personal side, I have had many opportunities to help others navigate and negotiate complex healthcare issues and have found this to be tremendously rewarding.

(7) Can you foresee any possible conflicts of interest that could arise during your service on the Hawai'i Medical Board? How would you overcome conflicts of interest?

In my professional role I was required to closely monitor healthcare trainees and their training environments. I provided advice as needed to these trainees and their interactions with multiple entities and believe that I am very capable of recognizing any conflicts which may arise. If I believed I was in a controversial position I would likely discuss the situation with the Chairperson of the Board, the Deputy Attorney General or perhaps the Executive Director and ask for guidance. In the absence of such guidance I would declare myself as unable to participate; I would recuse myself from participation in that particular matter.

Dear Senator Baker and Committee Members:

The purpose of this letter is to recommend Mr. Gary Belcher for an appointed position as Public Member of the Hawaii Medical Board. Mr. Belcher has my strongest personal and professional recommendation.

Until December, 2020, I was the Chief Executive Officer and General Counsel of Hawaii Residency Programs, Inc. ("HRP"). HRP has employed and trained more than 60% of the resident trainees who have gone on to practice medicine in Hawaii. Every year, HRP sponsored more that 200 MDR or DOSR license applications/renewals before the HMB. I am therefore well acquainted with the requirements for medical licensure in Hawaii and the role of the Hawaii Medical Board in that regard.
