EXECUTIVE OFFICE ON EARLY LEARNING'S POSITION: Support

Good afternoon. I am Lauren Moriguchi, Director of the Executive Office on Early Learning (EOEL). EOEL supports the nomination and confirmation of Janice Kahoohanohano to the Early Learning Board (ELB).

EOEL is statutorily responsible for the development of the State's early childhood system that shall ensure a spectrum of high-quality development and learning opportunities for children throughout the state, from prenatal care until the time they enter kindergarten, with priority given to underserved or at-risk children.

The ELB was established as a governing board through Act 202, SLH 2017, and is responsible for directing the EOEL on how best to meet the developmental and educational needs of children, from prenatal care to entry into kindergarten; providing recommendations to EOEL on improving the quality, availability, and coordination of early learning programs; promoting collaboration across agencies and stakeholders serving young children; and appoint and evaluating the EOEL Director on an annual basis.

Mrs. Kahoohanohano is seeking appointment to the ELB as a representative of Hawaiian medium early learning programs. She is currently the Project Director of Preschools at 'Aha Pūnana Leo and has dedicated 27 years as a parent and employee to the organization and efforts to perpetuate the Hawaiian language and culture for our youngest learners and families. With her extensive experience administering Hawaiian-medium early learning programs, Mrs. Kahoohanohano satisfies the requirement of §302 L-1.6 and would be an asset as a member to the ELB.
