#### in SUPPORT of GOVERNOR'S MESSAGE 635 RELATING TO THE NOMINATION OF DAWN HEGGER-NORDBLOM TO THE ENVIRONMENTAL COUNCIL

Aloha e Chair Gabbard, Vice Chair Nishihara and Members of the Senate Committee on Agriculture and Environment,

The Environmental Council (Council) is established by HRS § 341-3, which also directs membership "to assure a broad and balanced representation of educational, business, and environmentally pertinent disciplines and professions, such as the natural and social sciences, the humanities, architecture, engineering, environmental consulting, public health, and planning; educational and research institutions with environmental competence; agriculture, real estate, visitor industry, construction, media, and voluntary community and environmental groups."

The functions of the Council are to serve as a liaison between the Office of Environmental Quality Control (OEQC) Director and the general public to make recommendations concerning ecology and environmental quality. The Council monitors the progress of the State, county, and federal agencies in achieving the State's environmental goals and policies. It issues an annual report with recommendations for improvement to the Governor, the Legislature, and the general public (HRS § 341-6). Finally, the Council promulgates administrative rules for implementing Chapter 343, HRS (HRS § 343-6).

Ms. Hegger-Nordblom has been serving on the Council since November 2020 as an interim member. Ms. Hegger-Nordblom's experience as a planner and working with federal, state, and local agencies both in the private sector and as a state employee is very valuable to the Council's work and contributes to the Council's discussions and roles. Ms. Hegger-Nordblom is based on Maui and therefore provides important representation for the neighbor islands on this statewide board. With respect to the Council's functions, duties, and powers, and in consideration of Ms. Hegger-Nordblom's experience as demonstrated on her resume and participation to date, the Council supports her nomination and confirmation to serve on the Council.

Aloha Senate Committee on Agriculture and Environment,

Thank you for allowing me to make a statement on the following questions for the Senate Committee on Agriculture and Environment for GM635.

#### Why do you wish to be a member of the Environmental Council?

I want to do my part to serve the State of Hawaii and to protect Hawaii's environment for future generations. I believe everyone should volunteer and provide the time to invest in what they believe in. Being a member of the Environmental Council is one way I can give back to the community and use my skills to help the Environmental Council. I agree with the State's motto "the life of the land is perpetuated in righteousness."

## How do you perceive the role and responsibilities of a member of the Environmental Council?

The Environmental Council should be made up of a consortium of professionals that liaison with County and State agencies and the General Public regarding Hawaii's environmental goals and policies.

Given your understanding of the role and responsibilities of a member of the Environmental Council, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the Environmental Council.

Professionally I have extensive experience working with private clients and as a prior staff member working with the National Environmental Policy Act and the Hawaii Environmental Policy Act for the Department of Defense, Hawaii Army National Guard, City and County of Honolulu's Authority for Rapid Transit, and the Department of Land and Natural Resources, Office of Conservation and Coastal Lands. I have reviewed hundreds of Environmental Impact Statements and Environmental Assessments, pursuant to Chapter 343 HRS. I have the knowledge, skills and experience to aid in my

decision-making as a member for the Environmental Council. My key strengths are community planning, marine and terrestrial environments, climate change and sea level rise.

#### What do you hope to accomplish during your term of service?
