### Support for Governor Message 683, Michelle Pescaia Kahoolawe Island Reserve Commission

Aloha Chair Inouye, and Members of the Senate Water and Land Committee,

Thank you for the opportunity to offer strong support for Governor Message 683, Michelle (Miki'ala) Pescaia. This message is submitted for consideration and confirmation to the Kaho'olawe Island Reserve Commission for a term to expire 06-30-2025. **Participants in the Hawaii State Aha Moku (Aha Moku) supports this submittal.** 

The vision of the Kahoolawe Island Reserve Commission (KIRC) is to restore the *Kino*, the physical manifestation of *Kanaloa*, the native Hawaiian traditional name for Kaho'olawe. This entails the restoration of a healthy land and ocean ecosystem which is the foundation of  $N\bar{a}$  *Po'e o Hawai'i*, the native people of Hawai'i who believe and recognize the lands and ocean of Kanaloa as a living spiritual entity – a *wahi pana*, a sacred place.

A member of KIRC must be a part of the veneration and spiritual belief of the native Hawaiian community, particularly of the generational and traditional descendants of Kanaloa. Per translations of ancient chants and generational knowledge of original descendants of Kanaloa, the island is in every way attached to the Honualua Moku of Moku O Pi'ilani (Island of Maui). With the traditional understanding of the three moku of Kanaloa – Ko'olau, Kona and Molokini, the spiritual as well as the basic physical reestablishment of Kanaloa can be completed.

The kuleana of Miki'ala Pescaia is to preserve and perpetuate the language, culture, history, traditions and values of her Hawaiian ancestors and the people of Hawaii in the most relevant and responsible way; To steward the natural resources sustainably and wisely; to represent her community (and as a member of KIRC) to represent the lineal and generational people of Kanaloa; to act respectfully, responsibly with integrity; and to empower others to do the same.

Aha Moku supports this nomination and urges this Committee to confirm the nomination of GM 685.

### Aloha Kākou,

I am writing on behalf of the Protect Kaho'olawe 'Ohana ('Ohana) to recommend the reappointment of Michelle Miki'ala Pescaia (Ms. Pescaia) to the Kaho'olawe Island Reserve Commission (KIRC) for a full four-year term.

HRS Chapter 6K Kaho'olawe Island Reserve Section 5. Commission provides that "(2) Two members shall be appointed by the governor from a list provided by the Protect Kaho'olawe 'Ohana." The Protect Kaho'olawe 'Ohana provided a list from which Ms. Pescaia was first appointed to the KIRC on July 1, 2019 to complete a two-year term that expires on June 30, 2021. As she has effectively fulfilled the responsibilities of Commissioner since her appointment, we would like to recommend that she be re-appointed so that she can serve a full four years.

Ms. Pescaia's deep, personal connection with Kaho'olawe began twenty-five years ago with her first huaka'i (access) and participant in our annual Makahiki ceremonies. Since then she has returned many times as a restoration volunteer and to participate in cultural and religious ceremony. She has brought her family, students and fellow community members to Kaho'olawe to join-in the history and the generational work needed to restore this most sacred island. Ms. Pescaia is also actively involved in 'Ohana islands-wide meetings and continues to provide a unique, grounded perspective in all discussions.

Ms. Pescaia has served a full five year term on the Molokai Planning Commission, with one year as chair as well as several terms on the Molokai Island Burial Council. Through this service, she has developed a strong understanding of land use and management, historic preservation, cultural resource management, conservation, and politics. Serving on boards of several non-profits, she understands the components of business plans and management, volunteer programs, education and outreach, asset building, networking and liability. These are all assets that will be beneficial to service on the KIRC. Her resume is attached.

As we are asked to provide a list for Governor Ige to consider, our organization also includes Ms. Faith Kahale Saito and Mr. Jensen Kalama Chock for this nomination list. Their resumes are attached and they have submitted an online application to the State Boards and Commissions site. It is our hope that may be considered for any future openings and appointments.

Ms. Saito has a M.S. in Counseling Psychology and a B.S. in Family Resources from UH Mānoa. She is currently a Native Hawaiian Counselor at Honolulu Community College and formerly worked for the Kaho'olawe Island Reserve Commission as the Cultural Resources Project Coordinator. Ms. Saito is a Protect Kaho'olawe 'Ohana volunteer and kua leader.

Mr. Chock has a M.Ed. in Teaching majoring in Elementary Education and specializing in Hawaiian Immersion. He also has a Bachelor of Arts in Hawaiian Language and currently works for Kamehameha Schools as Kumu 'Õlelo Hawai'i and a Cultural Specialist for Ho'okahua in the Community Education Department. Ms. Chock is a volunteer, kua access support and Mo'o Lono in Training for the Protect Kaho'olawe 'Ohana.

### In consideration of **GOVERNOR'S MESSAGE 683 – SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE KAHOOLAWE ISLAND RESERVE COMMISSION OF GUBERNATORIAL NOMINEE MICHELLE PESCAIA**

Governor's Message No. 683 submits for consideration and confirmation, Ms. Michelle Pescaia to serve on the Kaho'olawe Island Reserve Commission (KIRC) in the seat reserved for the Protect Kaho'olawe 'Ohana (PKO). On behalf of the KIRC, I wish to express my strong support and recommendation for her confirmation.

In her first few years on the KIRC, Commissioner Pescaia has quickly indoctrinated herself into the operational and policy workings of the KIRC and has participated in many KIRC activities including completing certification as a KIRC Access Guide and representing the KIRC at the annual KIRC-PKO stewardship meeting. Commissioner Pescaia has provided a smooth transition for the KIRC from the previous PKO representative to herself. Prior to her time on the KIRC, Commissioner Pescaia has been intimately involved in facilitating volunteer access for the PKO to Hakioawa for both work and spiritual/cultural accesses. Her familiarity with the coordinating and managing PKO volunteer groups is an asset for the KIRC.

Ms. Pescaia was raised on Moloka'i and graduated from Kamehameha Schools Kāpalama. She later graduated from the University of Hawai'i at Manoa with a bachelor's degree in Hawaiian Language. Prior to her current position as Interpretive Park Ranger at the Kalaupapa National Historic Park, Miki'ala was a director for a Moloka'i summer school program and Moloka'i site coordinator for Nā Pua Noeau, University of Hawai'i Hilo. She has also served as a cultural education specialist at the Bishop Museum, an instructor at the Moloka'i extension of UH Maui College, and taught in the Punana Leo o Moloka'i Hawaiian Immersion Preschool.

The KIRC is truly fortunate to have the support and advice of Commissioner Pescaia on the commission and strongly supports her confirmation.

### TESTIMONY OF DAVIANNA PŌMAIKA'I MCGREGOR IN SUPPORT OF GM 683 CONFIRMATION OF MICHELLE MIKIALA PESCAIA TO THE KAHO'OLAWE ISLAND RESERVE COMMISSION

Chair Lorraine Inouye and members of the Committee on Water and Land, aloha kākou. My name is Dr. Davianna Pōmaika'i McGregor. I am a professor of Ethnic Studies and Director of the Center for Oral History at the University of Hawai'i Mānoa. I am also a member of the Protect Kaho'olawe 'Ohana. I am testifying in support of the confirmation of Michelle Mikiala Pescaia to serve on the Kaho'olawe Island Reserve Commission (KIRC).

Ms. Pescaia has a B.A. in Hawaiian language and currently works as an interpretive Park Ranger at the Kalaupapa National Historical Park. Prior to that, Ms. Pescaia was the Molokai Site Coordinator for Nā Pua No'eau on Molokai for 11 years. In her capacity, she educated a generation on Molokai in Hawaiian traditions and cultural practices, stewardship of wahi pana on Molokai and to accept the kuleana to perpetuate Moloka'i as a cultural kīpuka for Native Hawaiian culture as a whole.

Ms. Pescaia is a gifted Native Hawaiian educator, carrying on the legacy of her grandmother, Harriet Ne of Molokai and her 'ike/knowledge of Molokai wahi pana, history, cultural practices and the Makahiki. She and her 'ohana have been the piko (core) of the revival and perpetuation of the Makahiki on Molokai.

For the past 12 years Ms. Pescaia has brought her 'ohana, students and Molokai community members to Kaho'olawe, especially to open and close the Makahiki ceremonies. They have been a major force in the perpetuation of the Makahiki on Kanaloa Kaho'olawe and the associated rejuvenation of the island's natural resources with the seasonal rains that are called to the island through chants and offerings.

Foremost among her qualifications to serve as a commissioner on the KIRC is her culturally grounded leadership and team building skills.

Thank you for this opportunity to testify. I urge your committee to confirm the appointmen of Michelle Mikiala Pescaia to the KIRC. Aloha 'āina.
