The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> GM689, which would confirm OHA Nominee Scott Haili Mahoney as the Ka'ū regional representative on the Hawai'i (HIBC).

Mr. Mahoney resides at his family's homestead in Waimea, but traces his Haili 'ohana genealogy to Ka'ū and Kawaihae. Mr. Mahoney is currently retired and he has spent decades assisting with the removal of unexploded ordinance on Hawai'i Island, O'ahu, Moloka'i, and Kaho'olawe. Although he is not an archaeologist by training, Mr. Mahoney has accompanied many archaeologists on investigative assignments as safety support, while they conducted studies on archaeological resources and burial sites in dangerous areas. Additionally, in his free time, Mr. Mahoney remains actively engaged in various cultural and community organizations including the Royal Order of Kamehameha I, Kua'āina Ulu 'Auamo and its E Alu Pū Network, the Sovereign Councils of the Hawaiian Home Lands Assembly, and Mālama Kōloa (as he previously assisted with the restoration and protection of the Hapa Trail).

Through his experience Mr. Mahoney learned much about why and how to mālama iwi and developed a deep connection to the preservation and protection of iwi kūpuna. He has also taken every opportunity he has been presented with to learn about burial law and policy, studying *Hoʻi Hou I Ka Iwikuamoʻo*, the "Iwi Primer", as well as *Native Hawaiian Law: A Treatise*. Mr. Mahoney has served as a dedicated member on the HIBC since 2017. He brings this knowledge, kuleana, and willingness to continue learning to his candidacy for reappointment to the Hawaiʻi Island Burial Council.

For these reasons, OHA urges the Committee to <u>PASS</u> GM689 to confirm Mr. Mahoney to the HIBC. Mahalo for the opportunity to testify on this measure.

The Department of Land and Natural Resources (Department) supports Governor's Message 689, nominating Mr. Scott Mahoney to the Island Burial Council, Island of Hawai'i expiring June 30, 2024.

The Island Burial Councils are established under Section 6E-43.5, Hawaii Revised Statutes. The Councils determine whether to preserve or relocate previously identified native Hawaiian burial sites, recognize lineal and cultural descendants, and provide counsel and advice to the Department.

Scott Mahoney resides on his family's homestead in Waimea, Hawai'i. He has genealogical ties to Ka'ū and Kawaihae. For 20 years, Mr. Mahoney has participated in the removal of unexploded ordnances and it is through this experience that he has gained archaeological knowledge that included the identification of burial sites. He is a member of the Royal Order of Kamehameha. Scott is engaged in various cultural and community organizations including the Sovereign Councils of the Hawaiian Home Lands Assembly and Kua'āina Ulu 'Auamo. More importantly, Scott has been serving on the Hawai'i Island Burial Council for the last three years where he has earned and gained the respect of his fellow members.

Senate confirmation will ensure that Mr. Mahoney's knowledge and perspective informs the deliberations of the Hawai'i Island Burial Council until June 30, 2024.
