The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> GM691, which would confirm OHA Nominee Carol Lovell as the Kawaihau regional representative on the Kaua'i and Ni'ihau Island Burial Council (KNIBC).

Ms. Lovell was born and raised on Kaua'i and currently resides in Anahola, in the Kawaihau moku. She has been graciously serving on the KNIBC since 2017. Prior to her time on the council, she served for fourteen years as the director of the Kaua'i Museum, where she gained deep insight into Hawaiian history, culture, and burial practices. Mentored by many esteemed kūpuna, including Sara Malina Kailikea, Esther Makuaole, Roselle Bailey, and others, she learned proper protocols surrounding cultural artifacts and gained a deep respect for traditional knowledge and cultural resources. To inform her museum work, Ms. Lovell completed various trainings on Native American Graves Protection and Repatriation Act (NAGPRA) repatriation processes. She has also participated in the Kaua'i/Ni'ihau Island Burial Council's proceedings as an expert testifier, offering comments on inadvertently discovered artifacts. Ms. Lovell has designed and created lauhala reinternment baskets for iwi kūpuna since 2003. She has continued this important work through the present as it helps her to remain connected to the kūpuna and aware of their discovery, location, and treatment.

For these reasons, OHA urges the Committee to **PASS** GM691 to confirm Ms. Lovell to the KNIBC. Mahalo for the opportunity to testify on this measure.

In consideration of GOVERNOR'S MESSAGE 691 SUBMITTING FOR THE CONSIDERATION AND CONFIRMATION TO THE ISLAND BURIAL COUNCIL, ISLANDS OF KAUA'I AND NI'IHAU, GUBERNATORIAL NOMINEE, CAROL LOVELL FOR A TERM TO EXPIRE 6-30-2025

The Department of Land and Natural Resources (Department) supports Governor's Message 691, nominating Ms. Carol Lovell to the Island Burial Council, Islands of Kaua'i and Ni'ihau expiring June 30, 2025.

The Island Burial Councils are established under Section 6E-43.5, Hawaii Revised Statutes. The Councils determine whether to preserve or relocate previously identified native Hawaiian burial sites, recognize lineal and cultural descendants, and provide counsel and advice to the Department.

Carol Lovell is a resident of Anahola, Kaua'i. She previously served as the Kaua'i Museum Director for 14 years and in that capacity, became knowledgeable and experienced in the Native American Graves Protection and Repatriation Act. Her responsibilities as director also required her becoming familiar with Hawai'i's laws and administrative rules regarding native Hawaiian burials. She is also fortunate to have received mentorship from well-known and respected kupuna of Kaua'i. It is through that mentorship that she has learned proper protocol surrounding cultural artifacts and subsequently gained a respect for traditional knowledge and cultural resources. Ms. Lovell has been serving on the council for four years now where she is well respected.

Senate confirmation will ensure that Ms. Lovell's knowledge and perspective informs the deliberations of the Kaua'i Ni'ihau Islands Burial Council until June 30, 2025.

Aloha Luna Hoʻomalu Maile Shimabukuro, Hope Luna Hoʻomalu Jarrett Keohokālole and members of the Senate Committee on Hawaiian Affairs:

The Association of Hawaiian Civic Clubs whole-heartedly **supports** the nomination of Carol Lovell to the Kaua'i and Ni'ihau seat on the Island Burial Council. Since 2013 Carol has been a member of the Kuini Pi'olani Hawaiian Civic Club; a thematic Maui Council Chartered Club of the Association of Hawaiian Civic Clubs – whose main focus is the advocacy and support of 'Ōlelo Hawai'i. Carol's career as the Director of the Kaua'i Museum definitely lends to her credibility to this seat for which she is seeking a second term. I have known Carol for more than 20 years in her capacity as a member of the Kaua'i Chapter (Hālau 'O Kapi'olani, Helu 'Ekolu, Inc.) of the Hale O Nā Ali'i O Hawai'i for which I serve as Ikū Nahalani (Premier). Carol was initiated into the Hale O Nā Ali'i O Hawai'i on March 10, 1990 and has served as Ikū Moe (Marshall at Arms), Ikū Kau (Recording Secretary) and Ikū Ha'i (Chapter President); a position in which she currently has been serving since 2009. Carol has also served the State Association of Hale O Nā Ali'i O Hawai'i as its Ikū One Nui (State Treasurer). During her tenure as State Treasurer, she codified the Hale O Nā Ali'i O Hawai'i O Hawai'i Association's 501c10.

In November 2018, I traveled with Carol Lovell to Ni'ihau, a part of her Burial Council kuleana area. Carol, having this experience, amplified by her well-established relationships with many of the Ni'ihau Community only lends itself better to strengthen her position as the Kaua'i and Ni'ihau member of the Island Burial Council.

In consultation with the Kaua'i and Maui Council Presidents of the Association of Hawaiian Civic Clubs and its Executive Committee, the Association fully **supports** the nomination and selection of Carol Lovell as the Kaua'i and Ni'ihau member of the Island Burial Council.

The civic club movement was founded in 1918 by Congressional Delegate Prince Jonah Kūhiō Kalaniana'ole with the creation of the Hawaiian Civic Club; the Association was formally organized in April of 1959; and has grown to a confederation of sixty (60) Hawaiian Civic Clubs located throughout the State of Hawai'i and the United States. The Association is the oldest Hawaiian community-based grassroots organization. The Association is governed by a 16-member Board of Directors; advocates for improved welfare of Native Hawaiians in culture,

health, economic development, education, social welfare, and nationhood; and perpetuates and preserves language, history, music, dance and other Native Hawaiian cultural traditions.
