In consideration of GOVERNOR'S MESSAGE 700 SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE NATURAL AREA RESERVES SYSTEM COMMISSION, GUBERNATORIAL NOMINEE, THORNE ABBOTT, FOR A TERM TO EXPIRE JUNE 30, 2025.

The Department of Land and Natural Resources (Department) strongly supports Governor's Message (GM) 700, nominating Mr. Thorne Abbott to the Natural Area Reserves System Commission (Commission) for a term to expire June 30, 2025.

Mr. Abbott's experience in coastal management, protected areas, and species of special concern is a valuable asset for the Natural Area Reserves System Commission. Mr. Abbott has worked in government, private non-profit, education, and research sectors. Based on this experience, he has developed cross-jurisdictional multi-sector approaches to solving complex environmental problems.
