The policies and decisions made by HDOA impact the viability of our farmers and ranchers and determine the future of agriculture in our state. It's important that experienced and dedicated farmers are part of the decision-making process and I am committed to devoting my time and energy to this endeavor.

2. It is an honor to serve on the Board of Agriculture that is charged with establishing the broad operating policies for the Department.
