Testimony Re: GM750 - Nomination to Tax Review Commission

Aloha Senators:

Thank you all for considering my nomination to the Tax Review Commission (the "Commission"). I greatly appreciate your time and attention. The chance to serve on the Commission is an opportunity for me to serve my home state and help residents and their representatives to evaluate and learn about the practical effects of Hawai'i's tax structure. I believe my education in accounting, experience as a practicing tax attorney, and desire to commit these tools to public service would be valuable assets to the State and the current members of the Commission.

The impact of Hawai'i's tax structure cannot be understated. Our State's tax laws are used not only to raise revenue for the State, but also to enact economic, social, and environmental policies through financial incentives. Yet, despite the omnipresent reach of Hawai'i's tax laws, they remain complex and imposing for anyone attempting to understand them. A public that understands how it is taxed is more likely to not only pay its taxes, but also pursue meaningful ways to make its system fairer, more equitable, and efficient. I hope to assist the Commission in its review of Hawai'i's tax system by rendering findings that are useful and understandable to the public. Thus, I humbly ask for your support for my nomination to the current vacancy on the Commission.

(1) Why do you wish to be a member of the Tax Review Commission?

Public service is both an honor and a duty for citizens committed to representative governance. As a native Hawaiian who intends to stay and raise his family in Hawai'i, I want to contribute my knowledge and skills to making my home a better place. I am privileged enough to understand tax law, a subject that most would find foreign, and want my education and professional experience to help the place that I call home. I believe that my background in tax and accounting will allow me to contribute to meaningful discussions on the Tax Review Commission (the "Commission") and ensure the fiscal stability of the State and its residents.

(2) How do you perceive the role and responsibilities of a member of the Tax Review Commission?

The responsibilities of the Commission are clear under HRS § 232E-3. Members are entrusted with evaluating the State's tax structure using standards such as equity and efficiency and providing an evaluation to the legislature. In practice, I believe this requires members of the Commission to constantly solicit input from tax experts, residents and businesses in the State so that they can fully understand the effects and consequences of the current tax structure on all stakeholders. Members must then be honest and practical in their assessment of what can be done to make the State's tax structure more equitable, efficient and sustainable. Finally, given the complexity of tax law, members must make the public and their representatives can interpret and use the Commission's findings to evaluate policy decisions.

(3) Given your understanding of the role and responsibilities of a member of the Tax Review Commission, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the Tax Review Commission.

I currently practice as a tax attorney at Chun Kerr LLP. My job affords me the opportunity to work with a variety of clients including individuals, nonprofits, and businesses – all of whom are affected by the State's tax laws. In addition, I have worked with the Department of Tax and Attorney General's office in addressing tax disputes. The experiences of all of these stakeholders should be accounted for in the Commission's evaluation of the State's tax structure. In addition to my legal practice experience, I hold bachelor's and master's degrees in accounting from the University of Denver, which will allow me to understand the accounting, valuation, and financial reporting concepts that the Commission regularly deals with.

(4) What do you hope to accomplish during your term of service?

I hope to provide a practical and meaningful evaluation of the State's tax structure from a legal perspective. I would also work to make the Commission's report as clear, concise, and accessible as possible, in the hope of helping the public understand a subject of law that is often viewed as complex and confusing by the public.

(5) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the Tax Review Commission?

I believe that am humble enough to admit that I cannot know everything about \ tax laws, which will allow me to be both open-minded and eager to hear viewpoints that might not coincide with my own. The more I learn while on the Commission, the more useful I will be.

I am also honest, which allows me to share my point of view even when my positions may not appear popular or easy to accept. I will be honest in my assessment of the State's tax structure and will critically approach topics that must be investigated.

I also believe that I am practical. I try to approach situations with an understanding that we cannot let perfect be the enemy of good. Tradeoffs are a fact of life, something that is especially true when it comes to tax law. I do not view a membership on the Commission as carte blanche to call for massive overhauls to our State's tax structure because if the Commission's suggestions are to be taken seriously, those suggestions must be feasible.

(6) Name one previous experience that would make you stand out. How would this benefit the Tax Review Commission?

Prior to practicing law, I taught tennis at Kamehameha summer school. Teaching children from 3rd to 8th grade showed me how to take complex tasks, such as a tennis serve, and explain them in a way so that beginners could understand them. Being able to teach something is the hallmark of showing that you understand it. I look forward to educating the public in the same way on one of our more complex legal subjects while on the Commission.

(7) Can you foresee any possible conflicts of interests that could arise during your service on the Tax Review Commission? How would you overcome any possible conflicts of interest?

Given the extensive range of the State's tax laws, the Commission's evaluation of the State's tax structure could touch on issues or topics that affect me and my clients. However, I do not believe that my actions on the Commission would create any benefits or conflicts of interest because of the analytical nature of the Commission's findings. Any of my suggestions while on the Commission would be openly discussed, vetted, and examined by other members before making it into the Commission's reports. I trust that all of the Commission's recommendations will undergo the necessary critical discussion before being issued. Furthermore, in the unlikely event that any conflict of interest does arise, I would be honest and forthcoming in disclosing that conflict with Commission members on the record so that they and the public could be fully apprised of the situation.
