Submitting for Consideration and Confirmation to the Disability and Communication Access Board Gubernatorial Nominee, Summer Kozai For a Term to Expire June 30, 2025

The Disability and Communication Access Board (DCAB) supports the re-nomination of Ms. Summer Kozai to the Board for a second full-term to expire on June 30, 2025.

The Disability and Communication Access Board is a statewide Governor-appointed Board with a majority of its members being persons with disabilities or family members. The Board's mission is to advocate and promote full inclusion, independence, equal access, and quality of life for persons with disabilities in society.

DCAB is mandated to have persons with disabilities or their family members serving as a majority of members. Ms. Kozai fulfills this mandate as she is a person with a mobility disability. In addition, Ms. Kozai is a handler of her service dog, Trooper.

Ms. Kozai serves as the Chairperson of the Standing Committee on Parking. Her input as a user of parking stalls reserved for permittees with a placard has assisted the Board in amending its current Hawaii Administrative Rules, Title 11, Chapter 219, "Parking for Persons with Disabilities." A user of a service animal, she has been able to provide input on the issues relating to service animals. Ms. Kozai also serves as a member of the Board's Executive Committee.

In addition to her personal experience, Ms. Kozai brings strong analytical skills to the table as an auditor for the federal government and her dual Masters Degrees in Business Administration and Accounting. We value her past and continued input.

We ask that the Senate confirm Ms. Kozai to a position on the Board. Thank you.
