Dear Ms. Leisek:

Below are my answers to the questions as you requested.

#### (1) Why do you wish to be a member of the Contractors License Board?

I have been a Hawaii state licensed landscape contractor for 40 years and a Hawaii state licensed general contractor for 25 years. All of the work I have conducted under these licenses has been in the state of Hawaii. I believe I can provide experiential knowledgeable input to the responsibilities required of being a Board member.

(2) What do you perceive are the roles and responsibilities of a member of the Contractors License Board?

While HRS Chapter 436B Professional and Vocational Licensing Act, §436B-7 Powers and Duties of Licensing Authority clearly outline the role and responsibilities I would be bound to as a member of the Contractors License Board, I would emphasize public safety as a constant focus of all undertakings I would be involved in if elected to the Board.

(3) Given your understanding of the roles and responsibilities of a Contractors License Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

I have been a licensed landscape contractor since 1981 and a licensed general contractor since 1996 in the State of Hawaii, and have conducted contracting work primarily on Kauai, with occasional work done on Hawaii and Maui. Our company has done both small contracting work (under \$2,500) to large multi-million dollar contracts requiring coordination with multiple trade contractors. I believe this experience of understanding the needs of outer-

island contracting, as well as understanding details involved in both small and large construction projects gives me a unique perspective that I can share as a Board member.

(4) What do you hope to accomplish during your term of service?

During my term of service, I hope to provide the board with experiential knowledge and input to address situations unique to outer-island contractors and construction project owners.

- (5) Name three qualities that best describe you and how these qualities will benefit the Contractors License Board.
  - 1. Even-tempered: I will have respective interaction with other Board members as well as others outside the board
  - 2. Objective: I will assess issues fairly and without prejudice
  - 3. Attention to detail: I will collect and analyze as much pertinent information before providing my input.
- (6) Name a previous experience you've had that will be beneficial as a Contractors License Board member.

While not a single event, my previous experiences with working on large projects with other trade contractors provides me with knowledge of the needs and issues regarding many different trade contractors. I would believe that this knowledge would provide a unique perspective for the Board to utilize.

I was previously on the State of Hawaii Advisory Committee on Pesticides for a 4-year term from 2005 to 2009. I have been an active board member of the Contractors Association of Kauai for many years and have been the President for two terms.

(7) Can you foresee any possible conflicts of interest that could arise during your service on the Contractors License Board? How would you overcome conflicts of interest?

The only issue that I may see as a conflict of interest would be if a Board discussion directly affects an individual or entity that I am personally or professionally associated with. While I did list being objective as a quality that would benefit the Board and would be objective in my discussion, I would recuse myself from the specific matter if other Board members would be hesitant in my involvement.
