Through their fortitude and tireless efforts, Dr. Paloma and her team maintained a safe, healthy, and caring environment for our kupuna to continue to thrive in despite being physically distanced from loved ones during this pandemic.

With her experience in working for mission driven ali'i organizations and a collaborative spirit in finding solutions to address challenging community issues, Dr. Paloma will bring compassion, humility, and a community-focused perspective to the Board of Regents as it formulates policy to carry the University of Hawai'i forward for the next generation. Her professional career and her numerous community involvement demonstrate that the community and its needs are first and foremost in her mind. This is the kind of leader Hawai'i needs and the kind of Regent that will serve the University of Hawai'i well.
