Re: My Testimony Supporting the Confirmation of Mr. Downing

I am writing to voice my strong support for the appointment of Keith "Keone" Downing to the Board of the Hawai'i Tourism Authority. I've known Mr. Downing and his family longer than I can remember, probably over 50 years. I believe he will be an excellent addition to the Board, especially at this challenging time as Hawaii seeks to recover from the pandemic's economic devastation and rebuild its tourist industry in sustainable way.

Here are some of the reasons I believe that Mr. Downing is particularly suited for this position:

1. He has served as a member on the Board of Land and Natural Resources and I have witnessed in person his conduct in their hearings. In my experience, he was always well prepared, knowledgeable about the subject, asked pertinent and insightful questions, carefully considered comments of applicants, witnesses and fellow board members, and otherwise performed his job with dedication and diligence.

2. He grew up in a family which made its living in large part on the beaches of Waikiki providing beach boy services to visitors. Since early in the last century, when the Kahanamoku brothers plied the same trade, long before electronic media made the job easier, beach boys in Hawaii were the ambassadors of tourism and their sharing of Aloha with visitors helped spread the word about Hawaii's unique culture and environment. His father, George, carried that ethic forward into the last half of the century and passed it on to his family. Keone is intimately familiar with the need to carefully nurture this industry, as well as the need to do it with respect and aloha for visitors.

3. Mr. Downing is a small business owner who knows how to keep an eye on the bottom line, who knows the ups and downs of Hawaii's fragile economy, and who knows the importance of the visitor industry to Hawaii's working people.

4. Mr. Downing is a man of the sea who also grew up absorbing his father's concern and dedicated work toward the protection of Hawai'i's ocean environment and its residents' access to it. He worked with his father on those issues and now carries that work forward as head of the Surfing Education Foundation, a nonprofit affiliated with Save Our Surf, Hawai'i's first ocean-oriented environmental organization.

I recently spoke with Mr. Downing about the pandemic, its effect on his business and our state, the reopening of tourism and the challenges that lie ahead for the industry. I was impressed with his perspective on the need to meet Hawai'i's desire for tourist dollars while also maintaining our residents' quality of life.

He reminded me of the importance of word-of-mouth advertising and reviews that visitors provide to their friends upon returning home. He pointed out that decaying infrastructure like run-down beach park facilities and poorly maintained roads, along with the overcrowding of beaches and other attractions, and residents understandably disgruntled with poorly-managed resources, all have a very negative effect on the impression Hawai'i leaves with visitors. He sees clearly the need to carefully address these critical issues so that Hawai'i can maintain its rank as a first-class destination for visitors at the same time it remains a wonderful place to live.

I believe that Mr. Downing has the experience, knowledge, wisdom, vision and Aloha to help us bring back tourism in a way that satisfies the desires of visitors but balances that with the needs of our residents. I strongly urge that you confirm him as a member of the Hawai'i Tourism Authority.
