TESTIMONY OF NAHELANI WEBSTER ON BEHALF OF THE HAWAII ASSOCIATION FOR JUSTICE (HAJ) IN OPPOSITION TO H.B. 101

To: Chair David A. Tarnas and Members of the House Committee on Water & Land:

My name is Nahelani Webster and I am presenting this testimony on behalf of Hawaii Association for Justice (HAJ) in OPPOSITION to H.B. 101, relating to Tort Liability.

Chapter 520, known as the Recreational Use law, already grants private landowners limited liability from injuries and deaths that occur on private property if they open their lands to the public for recreational use at no charge. The purpose of the recreational use law already satisfies the intended purpose of the proposed legislation; to encourage private landowners to open lands and access to water to the public.

Adding language stating there is "no cause of action" is confusing. If the landowners actions are considered wilful or malicious, or if their house guest is injured, then they *would* have a cause of action under the exceptions listed in HRS 520-5. The current language in HRS 520 already provides landowners with protections from liability as well as stating clearly that liability depends on the circumstances and whether they fall into one of the exceptions.

When HRS 520 was enacted the legislature recognized that it was important to strike a balance between limiting liability to encourage public access to land and water areas for recreation, and protecting against conduct by an owner that is wilful or malicious. It is important that the interest of recreational use not outweigh the interest of protecting the public against unreasonably dangerous conditions. Sound public policy requires that all landowners, private and governmental exercise reasonable care in maintaining their property in a safe condition for the safety of the general public.

Amending the statute to allow for attorneys fees and costs would only serve to chill litigation against landowners who engaged in a wilful and malicious failure to warn against a dangerous condition for which the owner knowingly creates. This creates public policy which would place the public at greater risk. Furthermore, parties are already protected by the Hawaii Rules of Civil Procedure from frivolous suits (Rule 11, 54 (fees and costs upon judgment)).

If individuals are having difficulty getting onto private property because landowners claim fear of liability, then it is the best alternative to educate them of the already existing protections under the Recreational Use Statute. In addition, courts have already recognized a landowner's liability as limited, and therefore any further clarification to motivate landowners to allow people on their land for recreational purposes can be provided from existing case law.
