H.B. 1081, H.D. 1 RELATING TO SIDEWALKS

Senate Committee on Transportation

The Department of Transportation (DOT) **supports** H.B. 1081, H.D. 1, and offers comments. H.B. 1081, H.D. 1 requires the DOT and each county's transportation department to create and maintain a priority list of sidewalk installation and improvement projects and to publish the priority list on their respective websites.

The DOT supports efforts to improve the pedestrian network. We already have a comprehensive process in place to improve and maintain not only sidewalks, but the DOT's pedestrian network. The DOT's nationally recognized Statewide Pedestrian Master Plan reviewed existing conditions in the DOT's pedestrian network, including the location of facilities (e.g., sidewalks and shared use paths), pedestrian attractors, transit routes, census characteristics, and safety data. Based on existing conditions and input from the public and stakeholders, the project team identified thirty areas of concern and developed recommendations for improving those areas. The DOT has implemented half of the top ten project recommendations. In addition to the Statewide Pedestrian Master Plan, the DOT has existing maintenance contracts for its sidewalk network and maintains a complaint hotline and log for the public to use to notify the DOT of concerns on the DOT system.

The DOT is concerned that the bill's focus on sidewalks would inadvertently exclude rural areas that prefer not to have sidewalks/curb and gutter and prefer instead facilities such as shared use paths that are more consistent with the context of the location.

My name is Karissa DeWeerd, and I am a currently pursuing my Master of Social Work from the University of Hawai'i at Mānoa here in Honolulu. I support HB1081 HD1 requiring each county to create and maintain sidewalk installation and improvement projects.

As an aspiring social worker, I am committed to continually learning, exploring, and building community resources and assets. This is always important, but it is especially necessary during a pandemic. By passing HB1081 HD1, you will be promoting community wellness and safety here in Hawai'i.

According to the AARP, around 80% of Americans prefer communities with sidewalks.¹ They are considered great assets in communities and provide many benefits. One benefit of building and maintaining sidewalks is promoting an increase in community connectivity (i.e., between parks, local businesses, schools, etc.)² Additional resources by the U.S. Department of Transportation Federal Highway Administration state that sidewalks can also provide safety, reduce crashes, and promote physical activity.³ By passing HB1081 HD1, you can show residents of Hawai'i that you care about their physical safety and wellbeing.

Comments:

I support HB1081 requiring the transportation departments to create and maintain a priority list of sidewalk installation and improvement projects. This requirement will produce an inventory of pedestrian facilities within the state and subsequently accentuate where pedestrian facilities are needed. This is an equity issue as many of our older neighborhoods do not have sidewalks. Smart Growth America states that between 2008 and 2017 drivers struck and killed 49,340 people who were walking on streets all across America, this is an increase of 35.4% over this time period. This legislation will facilitate upgrading our roadways so that they are safe for all users.
