## H.B. 1081 RELATING TO SIDEWALKS

House Committee on Transportation

The Department of Transportation (DOT) **supports** H.B. 1081 and offers comments to address some concerns related to items in the bill. H.B. 1081 requires the DOT and each county's transportation department to create and maintain a priority list of sidewalk installation and improvement projects and to publish the priority list on their respective websites.

The DOT supports efforts to improve the pedestrian network. We already have a comprehensive process in place to improve and maintain not only sidewalks, but the DOT's pedestrian network. The DOT's nationally recognized Statewide Pedestrian Master Plan reviewed existing conditions in the DOT's pedestrian network, including the location of facilities (e.g., sidewalks and shared use paths), pedestrian attractors, transit routes, census characteristics, and safety data. Based on existing conditions and input from the public and stakeholders, the project team identified thirty areas of concern and developed recommendations for improving those areas. The DOT has implemented half of the top ten project recommendations. In addition to the Statewide Pedestrian Master Plan, the DOT has existing maintenance contracts for its sidewalk network and maintains a complaint hotline and log for the public to use to notify the DOT of concerns on the DOT system.

The DOT is concerned that the bill's focus on sidewalks would inadvertently exclude rural areas that prefer not to have sidewalks/curb and gutter and prefer instead facilities such as shared use paths that are more consistent with the context of the location. Also tracking only Capital Improvement Projects funds would not accurately portray the amount of funds expended on improving the pedestrian network because it leaves out funding expended on sidewalk maintenance as well as other pedestrian improvements (e.g., crosswalks, shared use paths) or pedestrian improvements completed as part of larger projects. Although the DOT has an existing process in place to improve and maintain the pedestrian network, in order to develop items specifically asked for in the bill, the DOT would need more time than allotted for by the existing initial deadline in the bill.

Good morning, Chair Aquino, Vice Chair Ilagan, and members of the House of Representatives Committee on Transportation. My name is Karissa DeWeerd, I am a current student in the University of Hawai'i at Mānoa's Master of Social Work (MSW) program here in Honolulu. I support HB1081 requiring each county to create and maintain sidewalk installation and improvement projects.

RE: Testimony for Bill HB1081 soliciting the section pf Fort Weaver Road, between Kilaha Street and Puuloa Beach Park, be added to HDOT's priority list of sidewalk installation projects.

Dear members of the Legislature of the State of Hawaii,

I am providing testimony as both a member of the Ewa Neighborhood Board #23 (ENB) and as concerned member of a neighborhood hui looking to improve the safety and usability of a section of **Fort Weaver Road, between Kilaha Street and Puuloa Beach Park** (herein referred to as the "Section"). This approximately 1.0 mile Section is the primary access to several schools (elementary, intermediate, and high schools) for all the children living in the area, yet **has no pedestrian access, lacking any sort of walkway, sidewalk, shared use path or bike lane.** 

Members of the surrounding community (including myself) have formed a hui and voiced their concerns for the safety of the Section, which is compounded by the fact that 1) it is a long straightaway with no speed tables, so vehicles travel extremely fast, and 2) by the fact that vehicles park vertically up against the edge of Fort Weaver Road, leaving no room for pedestrians to walk. The result of these issues is that the roadway is severely underutilized, especially by students, seniors, and persons with disabilities. It simply is not safe for pedesitrians. These issues were summarized in a Resolution that was passed by the ENB on 14 January 2021 by a vote of 10-0-0, which solicited the development of a shared-use path (i.e., a sidewalk) along the section. It is worth noting that there is plenty of room to install a sidewalk on either (or both) sides of the Section, as noted in the Oahu Pedestrian Plan.

Developing a sidewalk on the Section is also a question of equity. Over the past three decades the Ewa District has grown exponentially, with pedestrian and cycling infrastructure accompanying the development of the new neighborhoods. Meanwhile, the original neighborhoods (primarily developed in the 1950s and 1960's) have received

virtually no pedestrian or cycling infrastructure improvements. This inequity is most notable in the mile-long Section.

A sidewalk is urgently needed and would solve the existing issues by providing a safe area for pedestirans to walk. We strongly urge the Section be added to the Hawaii Department of Transportation's priority list of sidewalk installation projects.
