Title of Bill:	HB 1107, HD1 RELATING TO COMPUTER CRIME.
Purpose of Bill:	Adds aggravated harassment by stalking to the list of offenses upon which the offense of use of a computer in the commission of a separate crime may be based. Provides the court with the discretion to require the forfeiture of property used in computer crimes if the perpetrator was a minor, regardless of whether the minor owned the property. (HD1)

Department's Position:

The Hawaii State Department of Education (Department) respectfully offers comments on HB1107, HD1.

The Department agrees that any sort of bullying or harassment, whether online or through other means, should be addressed and resolved quickly and appropriately to ensure the safety of anyone being bullied or harassed. Unfortunately, the shift to online work and learning also shifts the method of bullying and harassment to a digital environment.

Based on the wording of the bill, it is the Department's understanding that the purpose focuses more on personal devices of students and their families. However, the language appears to be broader than this intent, allowing for a Department-issued (and owned) device to be seized. In either case, seizing a personal device or seizing a Department-owned device, if a student is accessing their education online, seizing a device may result in blocking a student from accessing their education. In criminal cases, as it does today, the Department would address the bullying and harassment pieces through its cross-office processes and would cooperate with law enforcement should there be information needed for an investigation.

The Department has mechanisms and processes in place for Department-owned devices,

including website content filtering to restrict access to inappropriate online content, filtering and restrictions for student and staff email accounts, and monitoring tools for devices. In the event of any reported bullying or harassment incident, the appropriate cross-office staff are called upon to address them. Depending on the nature of the incident, staff from student support, talent management, facilities and operations, and technology work together, along with law enforcement, to address and resolve the incidents.

I am Mikel Kunishima, Captain of the Criminal Investigation Division of the Honolulu Police Department (HPD), City and County of Honolulu.

The HPD supports House Bill No. 1107, H.D. 1, Relating to Computer Crime.

The amendments to Hawaii Revised Statutes (HRS), Section 708-893, Use of a computer in the commission of a separate crime, and Section 708-894, Forfeiture of property used in computer crimes, will assist in protecting the vulnerable youth from cyberbullying. Taking away the tools that perpetrators use to commit these crimes of bulling, cyberbullying, and harassment is the first step in addressing these serious issues that hinder student learning and the educational environment.

The loss of the perpetrator's tools (computers, tablets, smartphones, etc.) is paramount in stopping the misconduct.
