Aloha Chair Lee, Vice-Chair Inouye, and Members of the Committee:

HB1321, HD1 requires the posting of depth gauge signs, in a manner consistent with the Federal Highway Administration's Manual on Uniform Traffic Control Devices, on any portion of a public highway that lies within a special flood hazard area and is prone to flooding. Appropriates funds. Effective 7/1/2050. (HD1)

The Hawaii Emergency Management Agency (HI-EMA) supports House Bill 1321, HD1.

As the recent severe weather and resulting flooding that has afflicted the state clearly demonstrates, the need for accurate information and signage to keep the public informed is imperative. Installing depth gauge signs along public highways that lie within a special flood hazard area and is prone to flooding would be significant yet simple step to take. According to the manual on uniform traffic control devices, each flood hazard location would require two depth gauges and two warning signs. H.B. 1321, H.D. 1 RELATING TO TRANSPORTATION

Senate Committee on Transportation

The Department of Transportation (DOT) **supports** this bill to install depth gauge signs along public highways that lie within a special flood hazard area and are prone to flooding.

According to the manual on uniform traffic control devices, each flood hazard location would require two depth gauges and two warning signs. The total cost would be \$4,000.00 for each of these locations. Methods of signage and alerting the public through electronic devices are being considered.

Flood hazard sites as well as coastal road erosion and rockfall zones are currently being prioritized as part of DOT's resiliency study. Additionally, Light Detection and Ranging scan data will be reviewed to further analyze and measure the flood zone site to insure optimum installation. A prioritized list of flood hazard sites will be uploaded to the DOT website within nine months from the passage of this legislation.
