# HB 1344, RELATING TO THE HAWAIIAN HOMES COMMISSION ACT

February 5, 2021

Aloha Chair Hashem, Vice Chair Perruso, and members of the Committee:

The Department of Hawaiian Home Lands (DHHL) submits comments on this bill that removes acreage restrictions on leases of Hawaiian home lands for agricultural purposes; provides that the availability of the foregoing leases shall be subject to the availability of suitable tracts of land; and specifies that the foregoing leases may be for for-profit or non-profit purposes.

The Hawaiian Homes Commission Act (HHCA) as originally enacted by Congress authorized the Hawaiian Homes Commission to lease not less than twenty nor more than eighty acres of agricultural lands. The HHCA currently authorizes DHHL to lease no more than forty acres of agricultural lands. Removing acreage restrictions on leases of Hawaiian home lands for agricultural purposes should keep in mind that over 19,000 applicants are on the waitlist for an agriculture lease as of December 31, 2020 – 3,817 on Oahu; 4,666 on Maui; 7,269 on Hawaii Island; 2,235 on Kauai; and 1,097 on Molokai.

As farmers one of our biggest challenge is to sustain our crop's health and yields to harvest. Utilizing all tools available to us in timely coordination with our crops needs, is vital.

#### We respectfully SUPPORT HB779, with the following COMMENTS:

- We would like to suggest this program *not* be a "one-time" program, but suggest this be **considered as a** *permanent* state program similar to other successfully implemented programs in states that are supportive of agriculture as Hawaii is.
- We recognize the long-term value a program like this can have for Hawaii agriculture, and how it can help Hawaii farmers support the state's goal towards food security and sustainability.
- We also recognize that a no cost (or low cost) State Pesticide Disposal Collection Program will assist famers with pesticide disposal compliance, and is a win/win solution for our communities in which we live and farm.
- Regarding the administrative penalties: while we support the intent of enforcement, having members who are both commercial and private applicators, we are concerned with the amount of the fines proposed.
