SUBJECT: HB 1389 – RELATING TO THE HAWAII CORRECTIONAL SYSTEM OVERSIGHT COMMISSION.

Hearing: Friday, February 5, 2021, 10:0 a.m. Via Videoconference, State Capitol

DEPARTMENT'S POSITION: The Department of Human Services (DHS) respectfully requests clarification and provides comments.

<u>PURPOSE</u>: The purpose of the bill transfers the administrative attachment of the Hawaii correctional system oversight commission from the department of the attorney general to the department of human services.

Without understanding the nature of the conflict with the Department of Attorney General noted in the preamble, it is difficult to predict whether a transfer of the Hawaii Correctional System Oversight Commission to the DHS would avoid a similar or other conflict. DHS respectfully requests clarification as the mission and goals of the Commission are not related to the mission, goals, or programs of DHS and DHS is not a part of the Commission.

DHS offers the following comments on supporting administratively attached agencies as the relationship is more than a simple pro forma transaction. Any "hosting" department requires its own administrative resources to support an administratively attached commission or agency. The hosting department is required to absorb the commission's budget responsibilities, human resources, IT needs, communication, and facilitate procurement processes. In pre-pandemic times, other logistical support such as work space, parking, phone lines, internet, conference rooms, access to copiers were also required. For volunteer commissions, DHS staff are needed to support commissioners' travel, meetings, communications, and other logistics – all unfunded. Director's Office staff also receive UIPA requests, complaints, and various other inquiries regarding attached agencies. All of these administrative services require time and resources that take DHS staff away from their primary work and mission. For a transfer of the Hawaii Correctional System Oversight Commission from the Department of the Attorney General to DHS to occur, DHS will need additional resources to support this commission.

COMMENTS ON HB 1389 – TRANSFERRING THE CORRECTIONAL OVERSIGHT COMMISSION FROM THE AG TO HUMAN SERVICES

Aloha Chair Ohno, Vice Chair Ganaden, and Members of the Committee!

My name is Kat Brady and I am the Coordinator of Community Alliance on Prisons, a community initiative promoting smart justice policies in Hawai`i for more than two decades. This testimony is respectfully offered on behalf of the more than 4,100 Hawai`i individuals living behind bars or under the "care and custody" of the Department of Public Safety on any given day. We are always mindful that 1,000 of Hawai`i's imprisoned people are serving their sentences abroad thousands of miles away from their loved ones, their homes and, for the disproportionate number of incarcerated Kanaka Maoli, far, far from their ancestral lands.

Community Alliance on Prisons offers comments on this measure that seeks to transfer the administrative attachment of the Hawaii Correctional System Oversight Commission from the department of the attorney general to the department of human services.

While we support transferring the Commission out of the AG's office, which has proven to be an intentional disaster, we are not convinced that DHS is the proper agency – in fact any agency in the Executive Branch would not be good in our humble opinion.

The Department of Human Services has a HUGE mandate with many moving parts. It seems unwise to continue to attach different entities to that agency where they can get lost in the shuffle. A better fit would be to attach the Hawaii Correctional System Oversight Commission to the Ombudsman's office since their mission is to handle complaints against executive branch agencies.

Therefore, Community Alliance on Prisons urges the committee to consider our recommendation: Fund and Staff the Commission and attach it to the Ombudsman's office.

We can support the bill if the transfer is to the Ombudsman's office.

Testimony on HB621, HB1080, HB1082, and HB1389 February 4, 2021 House Committee on Housing, State of Hawaii

Aloha Honored Members of our State House Committee on Housing,

We fully support HB621, HB1080, HB 1082 and HB1389, all of which address important changes to our State corrections system.

- HB621 establishes a community working group to guide the redevelopment of the current Oahu Correction Center site. Acreage under the current Oahu Correction Center Site is a key community asset that should be redeveloped using principles and strategies that ensure their alignment with 'aina values and the sustainability, resilience, and health of current Kalihi residents. For the last two years, Kokua Kalihi Valley has been working with a collaborative of leaders focused on increasing community voice in urban development in Kalihi. We look forward to fully participating in this essential working group.
- HB1082, HB1080, and HB1389 phase out the use of private correctional facilities, transfer the Hawaii Correctional System Oversight Commission to the State Department of Human Services, and place a moratorium on the construction of new private correctional facilities in the State until such time as a reconfigured commission reviews, advises, and approves new construction and any correction facility expansions. We fully support this legislation. Many of our Kalihi subcommunities are over-represented in our prison systems, due to significant economic, social, and cultural barriers to equity and empowerment. Prisoners are among our beloved friends and family members and deserve a correctional system that minimizes the perverse and harmful incentives of the for-profit prison industry and that maximizes opportunities for humane and caring rehabilitation that employs the best practices of community, social and human service. Phasing out dependence on the for-profit prison industry and transferring the commission to the Department of Human Services are both important steps in creating a correctional system the better aligns with Hawaii's unique cultural and community values.

DEAR REPRESENTATIVES GANADEN, KAPELA, PERRUSO, and WILDBERGER:

RE: HB 1389 Transfer Administrative Support of the Oversight Commission from the Attorney General's Office to the Department of Human Services

I support HB 1389 without any reservation whatsoever. The following excerpt is quoted from the *Hawaii Correctional System Oversight Commission, Annual Report, December 2020:*

"The Hawaii Correctional System Oversight Commission was created by Act 179, Session Laws of Hawaii 2019, to "ensure transparency, support safe conditions for employees, inmates, and detainees, and provides positive reform towards a rehabilitative and therapeutic correctional system." The establishment of the Commission was a result of recommendations provided by the Task Force on Prison Reform to the Hawaii State Legislature... In 2016, in part to study and consider alternatives to massive construction costs, the Legislature determined "Hawaii's correctional system can benefit from the implementation of effective incarceration policies, programs, and best practices that aim to reduce correctional spending, alleviate inmate overcrowding at correctional facilities, lower recidivism, and address other challenges... Hawai'i's correctional system is not producing acceptable, costeffective, or sustainable outcomes and needs immediate and profound change."

Despite ongoing requests, the Attorney General's office has not provided appropriate administrative support, including releasing the budget for the Oversight Commission to act, effectively rendering the commission as ineffectual. Notwithstanding the fact the budget is more than reasonable for its intended goals, it is clear the AG's office does not view the commission or its service to the community as a priority or important. Conceivably, COVID-19 may be used to justify inaction. However, I urge the committee to look beyond any excuses and do the right thing by providing appropriate administrative support for the commission.

The Department of Human Services is better equipped to understand the significance of this commission's work and to provide administrative support. We need the commission

to be fully operational to address and act on many of the existing problems in the state's correctional system—which will benefit all of us.

Please support HB 1389 to Transfer Administrative Support of the Oversight Commission from the Attorney General's Office to the Department of Human Services.

A BILL FOR AN ACT

RELATING TO THE HAWAII CORRECTIONAL SYSTEM OVERSIGHT COMMISSION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Act 179, Session 2 Laws of Hawaii 2019, established the Hawaii correctional system 3 oversight commission as an agency attached to the department of the attorney general for administrative purposes only. Although 4 5 the Hawaii correctional system oversight commission has been in 6 existence for only one year, it has already had at least one conflict with the department of the attorney general. 7 The 8 possibility of future conflicts with that department may 9 interfere with the commission's ability to fulfill its critical 10 responsibilities.

11 The legislature further finds that the correctional system, 12 at its core, is as much a matter of health and human services as 13 it is law enforcement. Accordingly, the legislature believes 14 that it would be appropriate to transfer the Hawaii correctional 15 system oversight commission to the department of human services 16 for administrative purposes.

Dear Chair Ohno, Vice Chair Ganadan and Committee Members:

I am writing in support of HB 1389 that would transfer the administrative attachment of the Hawaii Correctional System Oversight Commission from the Department of the Attorney General to the Department of Human Services.

The Oversight Commission should not be administratively attached to the Attorney General's office for the following reasons: 1) it is not a priority of the Attorney General's office and 2) there is a perceived conflict of interest and potential actual conflict of interest having Attorney General counsel provide advise and counsel to the Oversight Commission while also representing the State of Hawaii Department of Public Safety.

Years ago, our correctional system was under the Department of Human Services. At that time, there was a greater focus on providing meaningful rehabiliation and opportunities to successfully reitegrate into the community. Eventually, the Department of Public Safety was created to house several "law enforcement" entities - Sheriffs, Corrections, etc. and there was a marked shift in philsopophy. We moved from rehabiliation to punishment, and an increase in the incarcerated populaiton and high recidivism rates.

The Oversight Commission's mission is more aligned with the mission and function of the Department of Human Services - both in philosophy and finding resources to meet the holistic needs of persons impacted by the criminal legal system.

Alternatively, another option is to administratively attach the Oversight Commission to the Ombudsman's office.

Please support this bill and transfer the Oversight Commission to the Department of Human Services or the Ombudsman's Office.

I am writing in support of HB 1389 which would transfer the administrative attachment of the Hawaii Correctional System Oversight Commission from the department of the attorney general to the department of human services.

It is undeniable that the Attorney General's office has been uncooperative and an obstacle to the work of the Hawaii Correctional System Oversight Commission. Perhaps another more responsive department with an interest in improving Hawaii's criminal justice system would be a more appropriate home for the Oversight Commission.

The Community Alliance on Prisons (CAP) has suggested that a better fit might be the Ombudsman's office whose mission is to oversee the executive branch agencies. I agree with CAP's recommendation that the Legislature fund and staff the Oversight Commission as was dictated by Act 179, passed in mid-2019.
