The Hawaii State Association of Counties (HSAC) strongly supports H.B. 161, H.D.2, which authorizes a county director of finance to withhold the issuance or renewal of a certificate of registration of a motor vehicle until the county is paid for any outstanding charges owed for the towing, removal, or disposal of an abandoned or derelict vehicle, except when the vehicle is stolen or taken from the owner without the owner's approval.

H.B. 161, H.D.2, will help in addressing the problem of abandoned and derelict vehicles. The more immediate problem, however, are the costs for the removal and disposal of abandoned or derelict vehicles, which in many cases, are absorbed by the county. In the County of Kauai, for example, in the last quarter of 2019, 247 abandoned or derelict vehicles were towed. Towing charges for that quarter totaled \$66,462.

Rather than imposing the burden of additional fees on the entire community, H.B.161, H.D.2, will impose the responsibility for the outstanding charges on those vehicle owners who contribute to the problem

For these reasons, HSAC supports H.B. 161, H.D.2.

The Patrol Services Bureau supports House Bill 161, which allows the Director of Finance of a county to require payment of outstanding charges owed to the county for the towing, removal, or disposal of an abandoned or derelict vehicle within the county before issuing a motor vehicle certificate of registration, except when the motor vehicle was stolen or taken without permission or authorization.

Bill 161 will drastically reduce the large number of vehicles that are carelessly abandoned around our counties. It will reduce the significant cost born by our taxpayers in the towing and disposal of these vehicles. In consideration of House Bill 161 HD2 Relating to the Registration of Vehicles

Honorable Chair Lee, Vice Chair Inouye, and Members of the Committee:

The Finance Department of the County of Kaua'i *strongly supports* HB 161 HD2, which allows the director of finance of a county to require payment of outstanding charges owed to the county for the towing, removal, or disposal of an abandoned or derelict vehicle within the county before issuing a motor vehicle certificate of registration.

The County of Kaua'i, like many other jurisdictions, has a major issue with abandoned and derelict vehicles. While our Kaua'i Police Department (KPD) is faced with addressing the towing and removal of these vehicles, the motor vehicle division is trying to work closely with KPD to address the root cause of the issue.

In preliminary discussions with KPD, they have a difficult time enforcing the collection of outstanding towing and related costs. In addition, there are recurring offenders who litter our island with cars. When their names were mentioned in our meetings, our motor vehicle staff indicated that they are regularly in the DMV transferring and registering vehicles.

While the HRS grants the Finance Director with leverage over some outstanding citations, it does not give authority over charges related to the towing, removal, and disposal of abandoned and derelict vehicles. If we were able to turn away these recurring offenders from transferring and/or registering vehicles, it would either force them to pay the bills that are now being absorbed by KPD or it would prevent them from improperly disposing these additional vehicles.

It is for these reasons, that we *strongly support* HB 161 HD2. Thank you for your consideration of this testimony.

Thank you for the opportunity to testify in **SUPPORT** of **HB 161 HD2**.

As the agency tasked with administering and enforcing HRS. Ch. 290, the legislation pertaining to Abandoned and Derelict Vehicles on public and private roadways, we think that this bill will achieve two desired outcomes:

1. It will effectively deter owners from abandoning their vehicles, and;

2. It will assist the counties with recovering the costs associated with towing, storage, and disposal of abandoned and derelict vehicles.

The County of Maui tows and manages a disproportionately high number of abandoned vehicles compared to the other Counties, towing and disposing of over 1500 vehicles per year. Many of these vehicles are stripped of parts and/or burnt, causing environmental and public safety hazards on all three of our inhabited islands, Maui, Lana`i, and Molokai. In Fiscal Year 2020, the Abandoned Vehicles and Metals Office towed 1650 vehicles at a cost of \$706,797.40, recouping only 11% of outstanding charges through Demands for Payment and use of a collection agency. The annual budgeted operational funds expended per year for abandoned vehicle administration and handling is over \$1,000,000, due to additional charges for vehicle cleanouts, special cleanups, and related costs. We believe this measure will cause the rate of fiscal recovery to at least quadruple within a year and will significantly reduce the burdensome task of removing abandoned and derelict vehicles from public roadways and properties

The Department of Environmental Management has already established a good working relationship with the Motor Vehicles & Licensing Division of the Department of Finance, and is prepared to successfully collaborate on implementing this law, should it pass.
