Dear Chair Lowen, Vice Chair Marten, and members of the House Committee on Energy and Environmental Protection:

We submit this testimony on behalf of Enterprise Holdings, which includes Enterprise Rent-A-Car, Alamo Rent-A-Car, National Car Rental and Enterprise Commute (Van Pool).

Enterprise **opposes** H.B. 193 which would grant authority to the counties to regulate the number of rental motor vehicles within their respective jurisdictions.

We believe that granting such authority would be detrimental to the counties and the State. Prior to the COVID pandemic, the entire rental car fleet in the state of Hawaii constituted only 5% of the total amount of registered vehicles in the State. Since COVID, rental cars make up only 3.5% of the total amount of registered vehicles. On Kauai, rental cars make up 7% of all registered vehicles; on Hawaii Island: 5%; on Maui: 7%; and on Oahu: under 2%. H.B. 193 unfairly targets the rental car industry and paints the industry as the main source of greenhouse gas emissions. But that is just not the case.

In fact, Enterprise's Commute business line promotes carpooling as an option that reduces the number of cars on the roads and helps reduce greenhouse gas emissions.

H.B. 193, which would likely be used to restrict rental car companies from operating at even their current COVID levels, would also severely restrict the amount of funds that the rental car industry contributes to the Highway Fund. Despite making up less than 4% of the total registered vehicles in the state, the taxes and fees assessed on the rental car industry make up 26% of the total revenue for the State Highway Fund. To add further restrictions to the operational capacity to the rental car industry would negatively impact the State.

I have personally been impacted by the large numbers of rental vehicles on Maui roads. From 2011 to 2019, I lived in my home in Haiku. Trying to get from Haiku to Kahului on the Hana Highway was almost impossible becuase of so many tourists using that road to get to and from Hana. Traffic clogged around Paia Town causing long delays to get through Paia town. To avoid the traffic jam, I would drove up on Kokomo Road, crossing over on Kaluanui Road, down on Baldwin Avenue, crossing over on Haliimaile Road, on Haleakala Highway, and finally onto Hana Highway to Kahului. I relocated to Wailuku in 2019 to avoid these road trips. Now I rent in Wailuku and rent out my home in Haiku.

In a way, I am reduced my carbon footprint by moving to Wailuku, but I would have rather stayed in my Haiku home if I had a shorter communte from Haiku to Kahului. So I ask the Legislature to support HB 193 to allow Maui County to reduced the total number of rental vehicles on Maui.

Dear Honorable Rep. Lowen and Rep. Marten and the Committee on Energy and Environmental Protection,

Thank you for giving me the opportunity to testify on the matter before your committee. As a West Maui resident traffic congestion is inevitable due to the influx of visitors, residents, natural disasters (fires, landslides), and vehicle/pedestrian accidents. As a West Maui Community Plan Advisory Committee member many meetings and discussions revolved around residents, visitors, traffic, infrastructure, Climate Change and Sea Level Rise.

The West Maui Community Plan guides future growth and development in West Maui over a twenty (20) year time frame. In 2017 there were approximately 25,000 residents. West Maui is the largest employment center in Maui. The daily average population identified in the plan was 63,706 people – which includes 10,287 residents who remain in West Maui during the day, 19,868 workers from West Maui and elsewhere who commute to West Maui, and 33,551 visitors. The plan noted the number of people that live, work, and spend time in West Maui put(s) a strain on roads, transit, infrastructure, housing, and other resources.

The COVID pandemic delayed visitors traveling to Maui and their use of rental cars. Facebook videos and pictures, and news outlets showed approximately 18K parked cars located adjacent to Kahului Airport. Conversely, traffic was less and commute times were bearable.

The Hawaii Tourism Authority's website on Monthly Visitor Statistics Island Highlights for Maui showed for the month of January 2020, "the average daily census grew 1.3 percent to 70,806 visitors." The Hawaii Visitor Statistic released for December 2020 noted, "there were 90,605 visitors on Maui in December versus 275,419 visitors a year ago. For all of 2020, arrivals decreased 74.1 percent to 791,660 visitors."

Sea Level Rise and Climate Change will directly affect Honoapiilani Highway and West Maui. Major portions of Honoapiilani Highway are located adjacent to the shoreline and are prone to flooding and coastal erosion today. The West Maui Community Plan identifies Climate Change and the potential effects to flooding, coastal erosion, and wildfires and the threats to residents, visitors, roads, critical infrastructure and properties.

The West Maui Community Plan's policy's, actions, and goals address limiting/reducing vehicle traffic and promoting rideshare opportunities. Policy 2.2.5 supports increased transit service within and between West Maui's neighborhoods, parks, and commercial areas, and between the Kahului Airport and West Maui hotels. Policy 2.2.10 supports improved resilience of the transportation system to climate change-related hazards such as Seal Level Rise, flooding and wildfires. Goal 2.2 - Action 2.08 identifies opportunities to partner with larger employers such as hotels, to sponsor bus passes, shuttles, rideshare, or other shared ride programs to connect employees to jobs. Action 2.10 provides a frequent direct Bus route between Kahului Airport to West Maui and hotels.

I support H.B. 193 to regulate the number of rental motor vehicles and to reduce greenhouse emissions.
