The Department of Public Safety (PSD) offers comments on House Bill (HB) 31, which would raise the maximum age of minors for which safe storage of firearms is required from sixteen years to eighteen years.

PSD is supportive of measures which increase the safe storage of firearms and prevent firearms from getting into the wrong hands. The enactment of this bill would only save lives.

Hawaii Firearms Coalition OPPOSES HB31.

Minors under age 18 can be responsible firearms and this bill would deny them the ability to use firearms in certain situations such as these and others:

<u>Self-defense is a primary reason for minors needing access to firearms</u>. It is not uncommon for minors to be at home alone when an incident occurs, such as a home invasion and other threats of violence. Or an adult may be at home but unable to access a firearm due to attempting to fend off an attacker or are disabled or elderly.

**Hunting and target shooting.** Hunting is a long time tradition for many families. Minors can grab a rifle after school and go hunting with friends or may be responsible for pest control around the house and farm. Or they may be a competitive shooter training for an event.

At one time, children were able to bring their rifle to school for rifle practice or after school hunting. Owning firearms teaches responsibility and accountability and you will notice this in children that are trained with firearms. Afterall, a minor can join the military at age 17 and drive a car alone at age 16. Raise the standard, don't lower it, for our youths.

As the NRA State Training Counselor for Hawaii, I will work with firearms instructors and gun stores to emphasize safe firearms storage and youth issues with improved instruction and signage to help mitigate the concerns mentioned in the bill.

I oppose HB 31. This bill, if passed will inhibit and/or restrict Hawaii's youth from engaging in marksmanship activities, in hunting or having the ability to defend themselves or their family in emergency situations. It also does not consider that the 17 years is the age that they may join the military service and have access to actual "weapons of war". If law makers truly want to reduce unnecessary death, then there should be mandatory safety classes implemented in the school curriculum, to include gun safety.

Training the youth of the United States of America in marksmanship has its roots going back to colonial times. Besides needing to hunt for food, Boys as young as 16 years to be trained as part of the Militia that would defend the community. President Theodore Roosevelt saw a great benefit to National Defense if citizen could be trained in marksmanship prior to military actual military service. The National Board for Rifle Practice (now known as the Civilian Marksmanship Program) was instituted to promote such training and government surplus rifles and ammunition was supplied to clubs and organizations to train marksmanship, and hold matches, and tournaments. These events included young people. The Boy Scouts of America and 4H clubs also have marksmanship programs. Junior Reserve Officer Training Corps (JROTC) programs at many High Schools have Marksmanship programs for Hawaii's youth. Many JROTC schools still have actual ranges, on school property, that are used to traing marksmanship. There are college scholarships for marksmanship. Youth that excel in these sports can receive a degree at different universities around the country.

This is a bad bill that will result in a bad law that will do little to prevent youth violence and cause the loss of youth opportunities.

Hi,

I am writing today to express why I oppose HB31. I am disappointed that I am having to take time out of my day again to oppose something that I feel I should not have to spend time on at all, as we simply do not have any issues regarding this topic in our state. I will not join in on band wagon manipulative tactics to harm firearm owners who are not causing anyone any issues by simply owning firearms at their homes and storing them as needed while abiding by the current laws.

I believe this law is unnecessary and limits storage capabilities and access in situations where an imminent threat of violence will occur, where a minor would be able to gain access to a firearm and prevent themselves from being harmed. I also feel this puts all firearms owners in Hawaii at potential risk due to the wording of the bill in regards to how firearms should be stored and what situations are considered to be breaking the law. I do not feel this would be properly taught to our community and firearm owners will be at unnecessary legal risk due to simply not knowing of these unnecessary changes with storage rules. My biggest concern is how will this be enforced and will this bill be placing families in harms way for law enforcement to gain access to check on how there Firearms are stored.

It would be illegal under the current laws for any minor to handle and operate another's firearm without permission and we are lucky to live in an educated society where people maintain and store their firearms without needing to be threatened in such a way, so that children do not have access to use them, unless given permission to do so in an emergency or for hunting if that is agreed upon and with adult supervision. Would a well trained and disciplined 17 year old who participates in firearms competitions on a national level not be allowed to defend themselves against a home intruder if it were to be absolutely necessary for them to remain unharmed? That is a horrible situation to try and imagine but it is a reality in today's world. I can recall stories of children much younger in other states that reasonably used firearms in defense against home intruders and thankfully neither the family nor the child were spoken down upon or threatened with jail time after. I would hope for the same results in Hawaii where I am a parent and a firearm owner. If a young girl was about to be attacked or had the option to use her fathers firearm in defense, I would personally hope she'd at least have the option without fearing any further negative recourse for herself or her father. That would

already be a horrible situation and no one should have to sit idly while they are assaulted and harmed by another.

This bill, in my opinion, was drafted to prevent violent attacks with firearms by those who are not allowed to use firearms already under our current state and federal laws. I believe strongly, as a parent, that if a child uses your firearm in a crime that all involved in the crime should be held accountable. That leaves accountability with those committing a crime and not with someone who technically had a crime committed against them, potentially by their own family. This bill would simply go after a person that was tragically harmed already by something far scarier than firearms, and that is human violence and aggression. If the parent had knowledge of the crime and were to be complicit in any way, then I am in total support of punishment being passed on to them for their part in the crime. There is no fair or justified reason why the parent of a person who commits a crime with a firearm with which they are not supposed to use is treated any differently than a person who's firearm is stolen and then used in a crime, as this is exactly what is occurring in that situation and they are the same. My child could also steal my car, a knife or many other objects and then proceed to use them in a crime. Why are other objects not being pursued for improper storage charges or anything of the sort if this is a fair bill? I do not want to be tried for the crimes of another and as a firearm owner I already work to protect my family and my investments and store my firearms in a safe way for everyone in my home without threat of violence or fines from the state. I am also able to stop a violent threat within seconds and follow all laws and that allows me to sleep comfortably at night in a world in which robberies and assaults seem to only be on the rise.

I think it's very important to express that I do not condone violence of any sort and I strongly feel that this type of bill, if passed and made into law, will directly lead to unnecessary violence between police officers and average/ currently law abiding citizens, due to but not limited to: false reports of firearm storage as the result of domestic disputes, angry neighbors, upset co workers or simply a stranger with no context and a wild imagination who is happy to call 911 and make a report.
