Aloha Chair Rhoads, Vice Chair Keohokalole and Committee Members,

The Hawaiian Humane Society supports the passage of House Bill 416, HD2, SD1, which would prohibit the use of specific tethering equipment and techniques that are injurious to dogs. It further prohibits the unsupervised tethering of dogs less than six months of age. Puppies lack the physical coordination to be safely left alone on a tether or pulley system. Crate training is preferable when puppies must be left by themselves.

Hawaiian Humane respects the importance of ensuring pet owners have options to keep their animals safe. We appreciate that HB 416, HD2, SD1, does not ban tethering, which would disadvantage pet owners who cannot otherwise secure their property or face lease restrictions that limit their options for housing their pets. Rather this bill requires that when tethering is used, it is safe for the animal. Proper tethering equipment is readily available and appropriate techniques are easy to implement.

Having a clear, enforceable tethering law also allows the county animal service providers to educate pet owners about other potential issues with dog tethering, such as keeping dogs isolated from human contact. Dogs are social beings who do best when fully integrated into their human families. Improper or prolonged tethering is frustrating to dogs, which increases the risk of serious dog bites. The victims of such attacks are often children.

l urge you to pass HB 416, HD2, SD1, to protect animals and people. Mahalo for your consideration.

Dear Chair Rhoads, Vice Chair Keohokalole, and members of the Senate Committee on Judiciary,

My name is Lindsay Vierheilig and I am the Hawaii State Director for The Humane Society of the United States. I am writing to express strong support for HB 416 HD2 SD1, which creates reasonable standards for chaining dogs who live outdoors. I appreciate the opportunity to submit this written testimony on behalf of our Hawaii members and supporters, and I am grateful to the legislature for recognizing tethering as a critical issue. While our hope is that every dog would share a home with his or her human family, we understand that is not always the case, so it is important that dogs who live outdoors be protected.

Constant, improper chaining puts a dog's health and safety at risk. In many cases, the necks of chained dogs become rubbed raw and covered with sores, the result of cruelly heavy chains, poorly fitted collars and the dogs' yanking and straining to escape confinement. Additionally, it is shockingly common for law enforcement to find dogs with embedded collars, a horrible situation where the collar grows into the skin, typically requiring surgery.

The vagueness of current law makes it difficult for enforcement officers who want to take action before a dog has suffered injury or death. Often, it is too late for the dog and the owner faces criminal charges. HB 416 HD2 SD1 will create clear guidelines for both owner and officer. The intention is not simply to punish violators, but to create reasonable expectations for the humane treatment of dogs and allow owners the ability to take proactive steps to comply.

HB 416 HD2 SD1 offers the following common-sense protections for Hawaii's dogs: a) ensures that dogs who are kept outdoors be provided proper and humane restraints, with collars that will not cause pain and tethers that are not egregiously heavy and b) ensures chained dogs are provided adequate food and water. HB 416 HD2 SD1 is an important step in protecting the people and dogs of Hawaii and we look forward to its passage. Thank you very much for your time.

The Humane Society of the United States requests that HB 416 HD2 SD1 be reported favorably.

My name is Rhonda Pollard, and I am a resident of Honokaa on Hawaii Island. I serve on the Hawaii Island Humane Society Board of Directors and support HB416 HD2 SD1.

Tethering becomes inhumane when a dog is kept chained alone in one spot for hours, days, months, or even years, and consequently, suffers immense physical and psychological damage.

The necks of chained dogs often become raw as a result of improperly fitted collars and their constant yanking and straining to escape confinement. Some chained dogs have collars embedded in their necks because their owners fail to replace the collars when the dogs outgrow them. Dogs also frequently become entangled in their chains or tethers, which limits the dogs' access to food, water, and shelter, and can cause serious physical injury. And the chains often weigh more than the dogs themselves, which significantly limits the dogs' range of movement. An otherwise friendly dog, when kept continuously chained, becomes neurotic, unhappy, anxious, and often aggressive. Animals that have been chained for the existence of their lives tend to show a higher potential for being involved in aggressive behavior so this also supports community safety. Animals that get off of chains do tend to be more aggressive than a typical animal.

Strict tethering ordinances are good for communities. For law enforcement and animal control officers, these ordinances create clear boundaries and expectations of pet owners. They allow for the employment and enforcement of citations and other penalties so the owner doesn't just go back to tethering their animals after the officer leaves. The specific and enforceable provisions of this bill will allow humane investigators to educate dog owners so they can correct violations while still keeping their pets safe on their property. For neighbors, because beyond physical danger from aggressive dogs, chained dogs also can be a public nuisance. These dogs are notorious for uncontrolled barking stemming from their lack of exercise, which leads to pent-up energy.

Tethering HB416 HD2, SD1

This bill rightly prohibits specified trolleys, pulleys, cables, or running lines designed to attach a dog to two stationary objects in a configuration that endangers the dog, including by even depriving the dog of sustenance, which is surely an act of cruelty.

It also prohibits the unsupervised tethering of a dog under the age of six months.

This gives dog owners the flexibility they need to keep their animals secure, protects the community from unsecured dogs if necessary, and ensures that dogs who have to be tethered are confined in ways that are safe and allow them adequate shelter, sustenance and freedom of movement.

We note also that SD1 prohibits tethering or restraining a dog with a choke collar, pinch collar, or prong collar unless the dog is engaged in an activity supervised by his/her guardian or an agent of the guardian.

We have to make the point that we are not in favour of these types of collar.

We understand that proper tethering equipment is readily available and appropriate techniques are easy to implement and that the provisions of the bill are meaningful and enforceable. Having a clear, enforceable tethering law allows the county animal service providers to educate companion animal guardians about other potential issues with dog tethering, such as keeping dogs isolated from human contact, which is undesirable as they are social beings.
