We respectfully request the Committee delete the language in HB416 and insert the language from HB1087, below.

We appreciate Rep Nishimoto's introduction of this bill but cannot support HB416 as drafted for the following reasons:

- The amended penalties, specifically adding "in lieu of" would potentially strike down the entire misdemeanor cruelty statute by removing the misdemeanor penalties.

- Judges already have discretion in issuing community service, which would never be recommended to be performed at a shelter or working with animals, for an animal cruelty offense. While we support judges, and prosecutors in submitting sentencing recommendations, requesting defendants who are minors participate in counseling, this should be in addition to any other criminal fines and penalties, not instead or in lieu of.

- The current language is unenforceable as it relates to the length of the tether being 10 feet, as some properties do not allow for a 10 foot lead, and in some cases may be unsafe, especially for a small dog. Further, the burden to demonstrate "repeatedly entangled" is difficult to enforce and may threaten the immediate safety of a dog if an officer must witness multiple violations before intervening to prevent death or injury to the dog.

We worked extensively with statewide animal care & control agencies, shelters and law enforcement on the language in HB1087, and would greatly appreciate your adopting that language instead.

Aloha and thank you for taking the time to act on behalf of our beloved family members; our pets.

During the past dozen years or so I have made numerous calls to the police and the Hawaiian Humane Society concerning dogs that have been tethered and/or caged 24/7. I will speak specifically about the cages since the owner has now moved from tethering to caging.

This owner has 4 or so dogs that remain outside in a cage 24/7. The ONLY time I have seen them out of the cage is when he takes them out to hose down the cages to get the feces out. Initially these puppies were kept together in one cage however now they are in separate cages. These cages do not provide relief from strong winds and heavy rains as we've recently been subjected to the past 3 weeks or so. Within the 50 states, Hawaii is listed as #40 in the legal protection of their pets; so much for the Aloha Spirit.

I have seen one of these dogs picked up by the scruff of the neck and slammed down to the ground and the owner then yells at the dog calling him a "faggot". Twice. It was obvious that the dog was scared as I heard the dog barking and trying to back up while laying low to the ground; I saw this when I looked out the window. Any dog lover can tell you this dog was very afraid. Regardless, the response is unacceptable and this dog owner should NOT be allowed to keep any type of pet if he chooses to keep it chained or in a cage 24/7.

The officer who came to the home after I called 911 told me flat out they wouldn't take the dog away even with something like that happening with an eye witness. I bet if that was your child that child would be taken away in a second.

I cannot understand why the laws do not protect our pets from this type of abusive behavior. As lawmakers, it is YOUR responsibility to protect our family members and this includes our pets. YOU all need to send a clear message that this type of behavior will not be tolerated. I have watched this happen for about 12 years now. I cannot even go to that side of the condo and lookout without feeling terrible for these cute animals.

Although I appreciate Representative Scott Nishimoto's bill, and I really really do, in my opinion it still lacks the necessary punitive damage and/or jail time or community service

that is needed to stop this type of behavior. For example, ..."Cruelty to animals in the second degree is a misdemeanor, except [where] that if the offense involves **ten or more** pet animals in any one instance..." should be changed to 5, or even 2. Not many homeowners have 10 pet dogs; even 1 is too much. This seems to apply to only puppy mills.

Hawaii has let this go on for too many years. It is time to take a stand. Right Now. We are the **only** ones who can protect our animals. So let's protect them. Don't "half-ass it" as my father would say (excuse me). If we don't have the laws to protect our pets the police won't or cannot take it seriously.

How serious do YOU take this? Make this legislation count or don't waste each others' time. I am hopeful that this legislative body will bring about change, REAL CHANGE, on how everyone should treat their animals and show everyone that if they do not, they will not longer have the privelege of having a pet.

I'd like to see Hawaii move to #1 as a state who takes seriously, cruel and inhumane actions against all animals.

Aloha Chair Hashem, Vice Chair Perruso, and Committee Members,

The Hawaiian Humane Society has been working with other stakeholders on the need to improve protections for tethered dogs for several years. We support the intent of House Bill 416 to advance this issue.

We have attached proposed amendments to this legislation that incorporate the input of dog advocates and law enforcement across the state. Some of the language in this bill has been flagged in prior sessions as being arbitrary (as in Section 1, 1 (g) iii citing the 10-foot length) or insufficiently specific (as in Section 1, 1 (g) iv referring to tow and log chains, which are inherently disproportionate to the size and weight of the dog and must be prohibited).

As written, HB 416 also has the potential to weaken the penalties in animal cruelty cases (Section 1, 2 inserting the phrase "or in lieu of" in the penalty section). Hawaiian Humane supports effective diversion programs, but courts already have wide discretion in imposing penalties and there is no evidence of over-sentencing in animal cruelty cases.

The Hawaiian Humane Society supports the passage of HB 416 with the attached amendments. I urge the committee to keep this measure moving so that we can work together to pass an effective bill. Mahalo for your consideration.

A BILL FOR AN ACT

RELATING TO SECTION 711-1109, HAWAII REVISED STATUTES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 711-1109, Hawaii Revised Statutes, is amended as follows:

1. By amending subsection (1) to read:

"(1) A person commits the offense of cruelty to animals in the second degree if the person intentionally, knowingly, or recklessly:

- (a) Overdrives, overloads, tortures, torments, beats, causes substantial bodily injury to, or starves any animal, or causes the overdriving, overloading, torture, torment, beating, or starving of any animal;
- (b) Deprives a pet animal of necessary sustenance or causes [such] that deprivation;
- (c) Mutilates, poisons, or kills without need any animal other than insects, vermin, or other pests; provided that the handling or extermination of any insect, vermin, or other pest is conducted in accordance with standard and acceptable pest control practices and all applicable laws and regulations;

- (d) Keeps, uses, or in any way is connected with or interested in the management of, or receives money for the admission of any person to, any place kept or used for the purpose of fighting or baiting any bull, bear, cock, or other animal, and includes every person who encourages, aids, or assists therein, or who permits or suffers any place to be so kept or used;
- (e) Carries or causes to be carried, in or upon any vehicle or other conveyance, any animal in a cruel or inhumane manner;
- (f) Confines or causes to be confined, in a kennel or cage, any pet animal in a cruel or inhumane manner;
- (g) Tethers, fastens, ties, or restrains a dog to a doghouse, tree, fence, or any other stationary object [by], or uses a trolley, trolley with swivels, pulley, cable, or uses a running line, or a trolley lacking swivels at each end that is designed to attach a dog to two stationary objects in a configuration that endangers the dog, including preventing the dog from obtaining necessary sustenance, provided that:
 - (i) No dog under the age of six months shall be tethered or restrained unless the dog is engaged in an activity supervised by its owner or an agent of its owner;

(ii) No dog shall be tethered or restrained by a tow or log chain; and If the dog is under the age of six months unless the dog is engaged in a
supervised activity;

- <u>(ii) In a configuration that repeatedly entangles or</u> otherwise endangers the dog;
 - <u>(iii)</u> <u>If the tether is shorter than ten feet in length</u>, <u>unless the dog is engaged in a supervised</u> <u>activity;</u>
- (iv) If the tether is a tow or log chain or is disproportionate to the size or weight of the dog such that the restraint inhibits the free movement of the dog within the area allowed by the tether; or
 - (v) No dog shall be tethered or restrained by means of a choke collar, pinch collar, or prong collar; provided that a person is not prohibited from using [such restraints] <u>a choke collar, pinch</u> <u>collar, or prong collar</u> when walking a dog with a hand-held leash or while a <u>unless the</u> dog is engaged in a <u>supervised an</u> activity <u>supervised by</u> <u>its owner or an agent of its owner</u>; or
 - (h) Assists another in the commission of any act specified in subsections (1) (a) through (1) (g)."
 - 2. By amending subsection (4) to read:

"(4) Cruelty to animals in the second degree is a misdemeanor, except [where] that if the offense involves ten or more pet animals in any one instance [which], then cruelty to animals in the second degree is a class C felony. In addition

to or in lieu of any penalty authorized for a person convicted of an offense under this section, the court may assess fines, order performance of community service, require mental health counseling, or order attendance at educational classes concerning animal abuse prevention."

SECTION 2. This Act does not affect rights and duties that matured, penalties that were incurred, and proceedings that were begun before its effective date.

SECTION 3. Statutory material to be repealed is bracketed and stricken. New statutory material is underscored.

SECTION 4. This Act shall take effect upon its approval.

Dear Chair Hashem, Vice Chair Perruso, and members of the House agricultural committee,

My name is Lindsay Vierheilig and I am the Hawaii State Director for The Humane Society of the United States. I am writing to express support for HB 416, which creates reasonable standards for chaining dogs who live outdoors, and urge passage with the amendments proposed by Hawaiian Humane Society. I appreciate the opportunity to submit this written testimony on behalf of our Hawaii members and supporters, and I am grateful to the House of Representatives for recognizing tethering as a critical issue. While our hope is that every dog would share a home with his or her human family, we understand that is not always the case, so it is important that dogs who live outdoors be protected.

Constant, improper chaining puts a dog's health and safety at risk. In many cases, the necks of chained dogs become rubbed raw and covered with sores, the result of cruelly heavy chains, poorly fitted collars and the dogs' yanking and straining to escape confinement. Additionally, it is shockingly common for law enforcement to find dogs with embedded collars, a horrible situation where the collar grows into the skin, typically requiring surgery.

The vagueness of current law makes it difficult for enforcement officers who want to take action before a dog has suffered injury or death. Often, it is too late for the dog and the owner faces criminal charges. HB 416 will create clear guidelines for both owner and officer. The intention is not simply to punish violators, but to create reasonable expectations for the humane treatment of dogs, and allow owners the ability to take proactive steps to comply.

HB 416 offers the following common sense protections for Hawaii's dogs: a) ensures that dogs who are kept outdoors be provided proper and humane restraints, with collars that will not cause pain and tethers that are not egregiously heavy and b) ensures chained dogs are provided adequate food and water. HB 416, with the amendments offered by Hawaiian Humane Society to ensure clarity, is an important step in protecting the people and dogs of Hawaii and we look forward to its passage. Thank you very much for your time.

For years, animal advocacy groups have been trying to pass this or similar bills in order to help raise the quality of life for "pets" on our islands. These bills have not successfully passed.

If you come to the beautiful, rural island of Molokai, you will be astounded by the beauty and the simple, laid-back lifestyle. It is truly a place that reflects Hawaii as it was many years ago. If you look a little closer, it is sometimes a shocking discovery to see the way that many of our dogs are treated. That mentality, too, is from many years ago, and it is *startling* to witness.

Animal Control has been both an unfilled position and inconsistent in enforcement, until a few months ago. Now, we have an officer in place that is willing and committed to increasing the quality of life for the many dogs on island that have ONLY experienced life on the end of a chain. I have witnessed them with no shade, food, or water, and eating their own feces for sustenance. I will never forget the little dog I found starving and covered with ticks on the end of a cable. Many of my students also knew of this dog. I contacted animal control, who contacted the owner, and it was determined that the situation was "okay" and the owner had just "forgotten to buy food." That dog was dead two weeks later. That dog is why I write this letter.

Our laws need to model compassion. If our laws model compassion towards animals, then our communities will model compassion, then our families, then our children. It is that simple.

Molokai Humane Society (MoHS) is the sole provider of animal care on-island. Our purpose is that we are "committed to building humane and caring bonds between the people and animals of Molokai." I urge you to pass HB 416, as a Molokai resident, a teacher, a MoHS board member, and a human being.
