Aloha Chair McKelvey, Vice Chair Wildberger and Committee Members,

My name is Michael Colón and I am testifying on behalf of Hawaiian Electric Company in **support of HB424**, relating to procurement of contracts for vehicle rental. Hawaiian Electric Company supports this measure as it aligns with and will help to bolster many of the Company's electrification of transportation initiatives.

HB424 encourages the State to be a leader in clean transportation and sends a strong, yet supportive, signal to car rental companies and indirectly the tourism industry. If passed, this bill will encourage car rental companies to add electric vehicles to their vehicle fleets with the confidence of having consistent EV rental clientele. It would also allow residents and visitors to experience electric vehicles while staying in Hawaii.

Hawaiian Electric's public charging program and upcoming proposed expansion is designed to support these such needs. #### HOUSE BILL 424 RELATING TO PROCUREMENT OF CONTRACTS FOR VEHICLE RENTAL

Chair McKelvey, Vice-Chair Wildberger, and members of the committee, thank you for the opportunity to submit testimony on HB424. The State Procurement Office (SPO) offers the following comments and recommendations:

COMMENTS: Chapter 103D, Hawaii Revised Statues (HRS), Hawaii Public Procurement Code (Code), is meant for general procurement methods and high-level. It should not be a receptable for all industry-specific specifications or goals as this will, over time, create a vast, and complicated Code that will confuse buyers because they will not be able to trust that specifications are in the respective chapter and procurement specific requirements are lost within the sea of specifications. Additionally, the current language prescribes the use of Request for Competitive Sealed Bid (IFB) method of procurement. It is not appropriate to require a specific method of procurement as there may be other methods that would be more appropriate to achieve the goals.

RECOMMENDATION: Remove language in its entirety and place in the subject-specific chapter for the Office of Energy in the HRS.

Chair McKelvey, Vice Chair Wildberger, and members of the committee,

Hawaii Gas offers <u>comments</u> on HB 424, which requires all state and county entities, when renting a vehicle on behalf of a state or local employee in the discharge of official government business, to rent electric or hybrid vehicles, in order of preference, provided that such a vehicle is suitable for the specific travel requirements and available when needed. Requires the State Procurement Office to promulgate rules and execute future contracts consistent with specified terms.

As technology evolves quickly and new options come to market, it's important to broadly define terms so as not to choose winners and losers in the technology that meets these needs.

We appreciate that in the bill's definitions section, "electric vehicle" includes a vehicle powered by "an onboard fuel cell." The Department of Energy reports that "A fuel cell uses the chemical energy of hydrogen or another fuel to cleanly and efficiently produce electricity." We ask for consideration that the definition of "electric vehicle" be amended to accurately reflect that.

Page 3 line 6

(2) Generated from an onboard fuel cell powered by hydrogen or other renewable fuel.

# In SUPPORT of HB 424 RELATING TO PROCUREMENT OF CONTRACTS FOR VEHICLE RENTAL.

Chair McKelvey, Vice Chair Wildberger, and Members of the Committee, the Hawaii State Energy Office (HSEO) offers support for HB 424, which requires all state and county entities, when renting a vehicle on behalf of a state employee in the discharge of official government business, to rent electric or hybrid vehicles, in order of preference, provided that such a vehicle is suitable for the specific travel requirements and available when needed.

Emissions from ground transportation account for the largest share of energy sector emissions in the state. As noted in the 2016 Greenhouse Gas Inventory, transportation emissions in Hawaii were at 8.69 million metric tons of carbon dioxide equivalents, accounting for 51 percent of total energy sector emissions. Ground transportation accounted for 47 percent of the transportation emissions. For Hawaii to meet its target to sequester more greenhouse gases than emitted as soon as practicable but no later than 2045, programs that support the adoption of cleaner transportation options are necessary and tremendously important.

The adoption and widespread deployment of electric vehicles is an essential component toward reducing Hawaii's dependence on fossil fuels. Requiring all state and county entities, when renting a vehicle, to prioritize the rental of electric vehicles will put

state agencies at the forefront of energy independence and greenhouse gas emissions reduction efforts. This requirement will provide an important market signal to prospective vehicle rental contractors, making it clear that demand for electric vehicle rentals exists and the State is committed to renting these vehicles as they are incorporated into vehicle rental fleets.

Electric vehicle rental prioritization for state and county employees is one of the recommended petroleum reduction tactics identified on page 9 of the Hawaii Clean Energy Initiative Transportation Energy Analysis, prepared for HSEO by the International Council on Clean Transportation. Incorporating electric vehicles into vehicle rental fleets will markedly increase exposure to electric vehicles, which can boost acceptance and adoption of electric vehicles by familiarizing travelers with the technology and operating characteristics of the vehicles. HB 424 aligns with the State's efforts to expand strategies and mechanisms to reduce greenhouse gas emissions through the reduction of energy use, adoption of renewable energy, and control of air pollution among all agencies, departments, industries, and sectors, including transportation.

One alternative in lieu of revising Chapter 103D, Hawaii Revised Statutes, could be that the State Procurement Office promulgate travel rules that require all state entities, when renting a vehicle on behalf of a state employee in the discharge of official government business, to rent electric or hybrid vehicles, in order of preference, provided that such a vehicle is suitable for the specific travel requirements and available when needed. Should this happen, HSEO is ready and able to support the State Procurement Office in this effort.
