## House Bill 515, House Draft 1, Proposed Senate Draft 2, Relating to Education

Dear Chair Dela Cruz, Vice Chair Keith-Agaran, and Members of the Committee:

The Board of Education ("Board") opposes HB515 HD1 Proposed SD2, which would require the Board to prioritize candidates for the superintendent of education position with certain minimum qualifications and establish a desired qualification.

The Board opposes proposed legislation that restricts its ability to hire and effectively manage and oversee the superintendent.

The Board respectfully disagrees with both the content and principle of this measure. This is essentially the Legislature dictating a management function over which the Board clearly has authority and responsibility as envisioned by the State Constitution. Further, while requiring superintendent candidates to have at least ten years of experience in a department of education would not have prevented the Board from hiring its current superintendent, it would have prevented the hiring of previous, longserving superintendents and limits the candidate pool for a position that already has a difficult time recruiting strong candidates.

Title of Bill:HB 0515, HD1, SD2 Proposed RELATING TO THE<br/>DEPARTMENT OF EDUCATION.

Purpose of Bill: Part I - Requires the auditor to audit the department of education's school food services branch to determine how much local produce is being purchased and served to students. Part II - Requires that the board of education prioritize for the superintendent of education position candidates that have the minimum qualification of ten years of employment in a department of education with at least five of those years serving in the capacity as a principal or higher and a desired qualification for a candidate is having a working understanding of the State's tri-level system of educational administration. (Proposed SD2)

### **Department's Position:**

The Hawaii State Department of Education (Department) supports the intent of Part I of HB 0515, HD1, Proposed SD2 to have the State auditor conduct an audit of the School Food Services Branch to determine the amount of local produce being purchased and served to students. The Department defers to the Board of Education regarding Part II of this bill.

The School Food Services Branch is currently performing its own internal audit to evaluate the amount of local produce purchased beginning with the 2019-2020 school year. Evaluating the prior year's procurements will assist the Department with assessing baseline amounts of local produce purchased prior to the COVID-19 pandemic.

I am Brian Miyamoto, Executive Director of the Hawaii Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawaii Farm Bureau supports Part I of HB 515, HD1, SD1, Proposed SD2, which requires the auditor to audit the department of education's school food services branch to determine how much local produce is being purchased and served to students. We take no position on Part II.

HFB strongly supports the increased use of locally grown agricultural products, fruits, vegetables, meats, dairy, and poultry products in our schools.

In previous sessions, when bills were introduced to remove the local agriculture preference and to return to exempting locally-grown agricultural products from the procurement code, HFB has requested clear metrics to help determine the success of the procurement code with the exemption.

Product purchase data help increase the purchase of more locally-grown agricultural products, fruits, vegetables, meats, dairy, and poultry products for our Farm to School program.
