In consideration of HB625 RELATING TO THE FESTIVAL OF PACIFIC ARTS.

Chair Gates, Vice Chair LoPresti, and members of the Committee.

The Department of Business, Economic Development and Tourism (DBEDT) supports HB 625 that extends the date on which the Temporary Commission on the 13th Festival of Pacific Arts will sunset to August 31, 2025; and permits Commission members to discuss matters outside of a public meeting to enable them to perform their duties faithfully.

The Festival, which was originally scheduled for June 2020, was rescheduled to 2024, due to the Covid-19 pandemic, thus making it necessary to extend the sunset date of the Commission.

The measure also permits Commission members to discuss matters outside of a public meeting. The Commission is a working group, having divided up the responsibilities of planning and implementing the Festival amongst the members. Therefore, there will be occasions when more than two Commission members will have to discuss matters in order to carry out their duties.

Thank you for the opportunity to submit testimony on this bill, which would exempt the Commission on the Thirteenth Festival of Pacific Arts from the Sunshine Law and extend its existence. The Office of Information Practices (OIP) takes no position regarding the length of the Commission's term or the work it is charged with, but has concerns regarding the proposed complete Sunshine Law exemption.

Although this bill states the Commission has the "intent" to follow the Sunshine Law, the bill would in fact make it completely optional for the Commission to do so. Public meetings, public testimony, keeping minutes, would all happen only when and to the extent the Commission wished to provide them. Further, the bill justifies the proposed exemption with a vague reference to the hands-on nature of planning a festival requiring "more than a quorum of commission members . . . to be able to communicate expeditiously" outside the Sunshine Law, but does not set out any specific situation that the members could not have handled using one of the Sunshine Law's existing permitted interactions. If the Commission truly is unable to accomplish its work within the Sunshine Law, OIP recommends that it explain what, specifically, it is unable to do under current law so this Committee can tailor a permitted interaction to its specific needs. OIP would be happy to assist in crafting a permitted interaction that would be more consistent with the spirit of the Sunshine Law.
