In consideration of HB 774 RELATING TO DEVELOPMENT DISTRICTS.

Chair Tarnas, Vice Chair Branco and members of the Committee. The Hawaii Community Development Authority (HCDA) **supports** the intent of HB 774 and offers following **comments**. HB 774 establishes the Pulehunui community development district for the purposes of developing public lands in Pulehunui, Maui, to provide suitable recreational, residential, educational, industrial, governmental, and commercial areas where the public can live, congregate, recreate, attend schools, and shop as part of a thoughtfully integrated community. HB 774 also establishes the Pulehunui community development authority placed within the HCDA for administrative purposes.

The "Authority", defined in HB 774 as the Pulehunui community development authority, may engage in planning, designing, and construction activities within and outside the district.
