Aloha Chair Luke, Vice-Chair Cullen and Members of the Committee:

The Department of Hawaiian Home Lands (DHHL) supports this bill authorizing the issuance of special purpose revenue bonds for a master planned development proposed by Pueo Development, LLC on Hawaiian Home Lands.

The Hawaiian Homes Commission (HHC) voted in August 2019 to approve the issuance of a Right of Entry permit to Waiohuli Hawaiian Homesteaders Association, Inc. (WHHA) for approximately 150 acres of Hawaiian home lands for the purpose of conducting due diligence studies including but not limited to project master plan, business plan, and related Chapter 343, HRS compliance requirements and Chapter 6E, HRS compliance requirements.

WHHA submitted a land use request to DHHL on December 3, 2018 with a proposed plan including development of residential and agricultural lots, economic and educational opportunities, energy projects, and water source development through collaboration and partnerships which would result in career development and employment opportunities. A beneficiary consultation meeting was conducted on May 30, 2019 to collect beneficiary input and feedback on WHHA's land use request. A beneficiary consultation report was submitted to the HHC in July 2019 for acceptance.

Aloha Chair Sylvia Luke, Vice-Chair Ty J.K. Cullen and Members of the House Committee on Finance. My name is Perry Artates, President of the Waiohuli Hawaiian Homestead Association, Inc, and I submit the following testimony in support of HB 776

This measure was introduced at last year's Legislative Session and received the support of your committee. However, due to COVID-19, the 2020 Legislative Session was suspended, and the measure stalled from advancing. We appreciate your committee's consideration on this measure again.

WHHA is a non-profit, 501(c)3 organization, who has partnered with Pueo Development, LLC, a Hawaii-based company to seek Hawaii State Legislature's authorization for a \$80M Special Purpose Revenue Bond (SPRB) to support WHHA's "Project: WE-DO" (Waiohuli Economic Development Opportunities).

Historically, WHHA received a land disposition from the Department of Hawaiian Home Lands (DHHL) in 2005 to a 17-acre parcel of land in Waiohuli Homesteads, Kula, Maui. Since then, WHHA has received strong support from the Legislature through the Grant in Aid Program. WHHA has leveraged community participation to create multiple facilities and infrastructure, including a certified commercial kitchen, patio banquet area, hale halawai, cultural garden and open amphitheater. Prior to COVID-19, these facilities have provided rental revenue which WHHA is using for educational scholarships. WHHA anxiously awaits overall relief from this pandemic.

As a result of their development experience, WHHA has focused on a new initiative, "Project: WE-DO". The goal of Project: WE-DO is to create long-term, economic development opportunities for WHHA's community THROUGH development including:

• career mentoring and employment opportunities associated with development

- collaboration with DHHL to create homestead opportunities and services, including new housing
- leveraging private and public financing commitments

DHHL issued WHHA a Right of Entry (ROE) #688 on January 7, 2020 to conduct necessary due diligence and project feasibility to develop a master plan on approximately 150 acres of DHHL located adjacent to the existing Waiohuli Hawaiian Homesteads. The initial due diligence period is 36-month, during which time WHHA's partner, Pueo Development, LLC plans to assemble a financing package for the master plan, inclusive of a Special Purpose Revenue Bond.

Special Purpose Revenue Bonds provide loan financing to assist qualifying private capital improvement projects in the public interest. The bonds do not constitute a general obligation of the State and are not State monies.

Pueo Development, LLC, in partnership with WHHA, requests to amend HB 776 to include "agriculture" as well as the addition of Part IV of chapter 39A "Processing Enterprises". Waiohuli's initial conceptual vision for a master-planned community included agriculture as an economic opportunity. The effects of COVID-19 have heightened the need for a more diversified economy lending focus to the State's goal of 30% food sustainability by 2030. Pueo Development and Waiohuli seeks to broaden investment interests in ag production and distribution to support economic development.

In closing, we seek your continued support for this measure to provide WHHA a chance to further self-sufficiency as Prince Jonah Kuhio envisioned.
