The justification for this bill is false. It is based on a single incident and cites no statistics that support the assumption that everyone who inherits firearms is more likely to commit crimes than those who purchase firearms. HB783 paints all surviving spouses with a broad brush. Because one person broke other laws, does not imply that all survivors should lose their means to self defense and their right to inherited property.

This bill fails to provide sufficient recognition of the importance of private property.

The requirements that this bill would impose on estate representatives are not needed and they would complicate settling estates. Firearms and other property should pass from the deceased automatically to the surviving spouse. Laws already require registration.
