Title of Bill: HB 0812, HD1 RELATING TO TRAUMA-INFORMED EDUCATION.

**Purpose of Bill:** Requires DOE to establish a threeyear pilot program for the development and implementation of a traumainformed education program in the Castle, Kailua, and Kalaheo complex areas, based on the NanakuliWaianae complex area traumainformed education programs and report to the legislature. Appropriates funds. Effective 7/1/2050. (HD1)

### **Department's Position:**

The Hawaii State Department of Education (Department) respectfully offers comments on HB 812, HD1.

The Department is committed to enhancing student resiliency, promoting compassion, and ensuring all students have access to a continuum of culturally responsive, trauma-informed/trauma-sensitive interventions and support.

The Department continues capacity-building efforts to foster

trauma-informed/trauma-sensitive education, implementation, and support across the state. Through teacher and staff trauma-informed/trauma-sensitive professional development, interagency partnerships, innovative initiatives, and a comprehensive and equitable system of trauma-informed/trauma-sensitive practices, services and resources are in place across the State. The following provides an overview of the Department's capacity-building milestones and initiatives:

• <u>Act 271</u>: In 2019, the Legislature passed Act 271, requiring the Department to establish

a task force to create a system for evaluating and assessing all children and those who are exhibiting emergent or persistent behaviors, academic challenges, or chronic absenteeism, and are in need of appropriate supports and interventions accessible within the continuum of a multi-tiered system of support. A comprehensive final report was submitted as a Legislative Report in July 2020.

- <u>U.S. Department of Education Trauma Recovery Demonstration Grant Award- Ho`oikaika</u>
   In September 2019, the U.S. Department of Education awarded \$5 million in federal demonstration grant funds to the Department to support students from low-income families who have experienced trauma that negatively affects their educational experience through the accomplishment of four major strategies:
  - 1. Strengthening core beliefs and mindset shifts toward trauma-sensitive schools focusing on empowerment.
  - 2. Further developing the screening process to include behavior and/or social and emotional learning screening, as well as a trauma-specific screening tool to strengthen Hawaii's Multi-Tiered System of Support.
  - 3. Identifying at-risk and improving progress monitoring.
  - 4. Developing effective partnerships with stakeholder agencies and organizations.

The pilot schools for this grant include:

- Kailua High School;
- Waimanalo Middle and Elementary School;
- Kau and Pahala School; and
- Naalehu Elementary School.
- <u>Trauma-Informed Practices Virtual Series</u>: In August 2020, the Department sponsored and recorded three (3) virtual professional development sessions led by local-based trauma experts. This statewide professional development provided learning objects in the following area; wellness and resilience strategies for distance learning, trauma-informed care strategies for preparing for the return to school, and the essentials of self-care.
- <u>Trauma-Informed Practices and Interventions Session for School-Based Behavioral</u> <u>Health Staff</u>: In December 2020 and January 2021, the Department sponsored and recorded a two-session professional development on trauma-informed practices and interventions. Led by Hale Kipa, the professional development focused on capacity-building skills of the School-Based Behavioral Health personnel across the state. These skills will enhance services and supports to include understanding the impact of trauma, the components of trauma-informed care, assessments, identification, and trauma-specific interventions.
- <u>National Council for Behavioral Health's 2020-2021 Trauma-Informed,</u> <u>Resilience-Oriented Approaches Learning Community</u>: The Department is participating in a nationwide trauma-informed learning community to equip the organization with tools,

resources, skills, and contacts to address the impacts of trauma and to nurture resilience.

The Department anticipates additional funds will be needed for the actual implementation of HB 812 based on the Nanakuli-Waianae's Trauma-Informed education program of nine schools, and provides the following budget breakdown of the 2017-2020 Trauma-Informed education program for review.

### RE: HOUSE BILL NO. 0812, HOUSE DRAFT 1, RELATING TO TRAUMA-INFORMED EDUCATION.

Chair Kidani, Chair Keohokalole, and Members of the Joint Committee:

The Hawaii Primary Care Association (HPCA) is a 501(c)(3) organization established to advocate for, expand access to, and sustain high quality care through the statewide network of Community Health Centers throughout the State of Hawaii. The HPCA <u>SUPPORTS</u> House Bill No. 0812, House Draft 1, RELATING TO TRAUMA-INFORMED EDUCATION.

As received by your Committee, House Bill No. 0812, would:

- (1) Establish a three-year pilot program within the Department of Education (DOE) to develop a trauma-informed education program (Program) in the Castle, Kailua, and Kalaheo complex areas, based on the Nanakuli-Waianae complex area's trauma-informed education program;
- (2) Require the DOE to report to the 2024 Legislature on its progress in implementing the Program, among other things; and
- (3) Appropriate an unspecified amount of general funds for fiscal year 2021-2022, and the same amount for fiscal year 2022-2023, for training purposes and the salary and benefit of one temporary twelve-month district educational specialist, to be located within the Office of the Castle-Kahuku complex area superintendent.

This bill would also take effect on July 1, 2050, to facilitate further discussion.

By way of background, the HPCA represents Hawaii Federally-Qualified Health Centers (FQHCs). FQHCs provide desperately needed medical services at the frontlines in rural and underserved communities. Long considered champions for creating a more sustainable, integrated, and wellnessoriented system of health, FQHCs provide a more efficient, more effective and more comprehensive system of healthcare. The experience of trauma has widespread impacts on the lives of our citizenry. This often leads to or exacerbates mental illnesses, substance use and physical health conditions. Because of this, in a truly integrated whole health system of health care, effectively treating behavioral and physical health conditions must involve the impact of trauma.

Unfortunately, despite the best efforts of policy makers, health care providers, and government workers, the very services and systems designed to help people become healthy can be re-traumatizing. This is especially true in our public schools, where traumatized youths and their support groups may feel overwhelmed by bureaucracy and a lack of empathy that makes more often than no makes their situation worse.

To address this, the Nanakuli-Waianae Complex has installed a very successful trauma-informed care system that provides essential emotional, educational, and health care support to those affected by trauma. This clearly is a model that should be duplicated throughout the State.

Accordingly, we respectfully urge your favorable consideration of this bill.

# Hale Kipa - a statewide youth services organization since 1970, strongly supports SB812 HD1 Relating to Trauma-Informed Education.

The Nanakuli/Waianae Complex Area, Trauma Informed Education program of 2014-2017 proved to be a grand success. Within 4 years, the number of all class incidents were drastically reduced along with the number of suspensions. Additionally, the teacher retention rates soared. The opportunity to establish a three-year pilot program for the development and implementation of a Trauma Informed Education for Castle, Kailua and Kalaheo Complex Areas based on the successful implementation in Nanakuli/Waianae are necessary more now than ever.

COVID-19 has brought on tremendous stress, depression and suicide across the nation and on our youth, and Hawaii is no different. According to the data collected from the Youth Risk Behavior Survey (YRBS) of 2019, over 11% of Hawaii's teens and 13% of our intermediate children attempted suicide. Various recent news articles have shed light on the increase in depression and suicide rates that have shown up across the state. The Castle, Kailua and Kalaheo Complex Area youth and HIDOE staff deserve a program that is mindful and deliberate in amplifying the infrastructure, support and recovery systems proven to be effective with a Trauma-Informed Education Program.

### HSAC Supports HB812 HD1:

ALOHA CHAIR, VICE CHAIR AND DISTINGUISHED COMMITTEE MEMBERS. My name is Alan Johnson. I am the current chair of the Hawaii Substance Abuse Coalition (HSAC), a statewide organization of over 30 substance use disorder and co-occurring mental health disorder treatment and prevention agencies.

Traumatic stress can arise from a variety of sources: bullying at school, dramatic weather events, school shootings — even the day-to-day exposure to events such as divorce or homelessness. Children *and* adults can be affected by traumatic stress. Having the tools to manage traumatic stress empowers the members of the school community.

In a trauma-informed school, the adults in the school community are prepared to recognize and respond to those who have been impacted by traumatic stress. Those adults include administrators, teachers, staff, and parents. In addition, students are provided with clear expectations and communication strategies to guide them through stressful situations. The goal is to not only provide tools to cope with extreme situations but to create an underlying culture of respect and support.<sup>1</sup>

FACT: One out of every four children attending school has been exposed to a traumatic event that can affect learning and/or behavior.
