The Department of Business, Economic Development & Tourism (DBEDT) provides the following comments on HB 862 HD2, Proposed SD1, which abolishes the Office of Aerospace Development (OAD), Aerospace Advisory Committee, and the Hawaii Unmanned Aerial Systems Test Site Advisory Board. Additionally, it transfers: administration of the Pacific International Space Center for Exploration Systems (PISCES) from DBEDT to the University of Hawaii at Hilo Imiloa and transfers the administration, along with all rights, powers, functions; duties of the Challenger Center Hawaii (CCH) program from OAD to the Department of Education (DOE); and all appropriations of CCH program from OAD to DOE.

OAD's mission is to facilitate dialogue and coordination among the state's government, private and academic sectors, and between state-based organizations and overseas institutions, both public and private, to promote the development and diversification of Hawaii's aerospace industry.

Since 2018, OAD has focused on prioritizing its initiatives to support the diversification of Hawaii's aerospace economy through drones, robotics, aviation education, and local conferences. Additionally, as a member of the Policy Committee in the Aerospace States Association, OAD makes sure that Hawaii contributes to the national aerospace policy recommendations.

Purpose of Bill:	Abolishes the office of aerospace development, aerospace advisory committee, and the Hawaii unmanned aerial systems test site advisory board. Transfers administration of the Pacific international space center for exploration systems from the department of business, economic development, and tourism to the University of Hawaii at Hilo Imiloa. Effective 7/1/2050. (HD2)

### **Department's Position:**

The Hawaii State Department of Education (Department) supports HB 862, HD2, SD1 proposed. The Department supports the Challenger Center Hawaii program to be transferred from the Office of Aerospace Development and placed within Department of Education for administrative purposes.

The Challenger Center Hawaii, one of more than 40 Challenger learning centers in the United States and globally, promotes a Science, Technology, Engineering and Math (STEM) education program. Challenger Center Hawaii's missions immerse students in a hands-on experience where they apply problem-solving and critical thinking skills.

These learning opportunities have served as a springboard for students to embark in STEM careers. Since 1993, over 132,000 Hawaii students have participated in a Challenger Center Hawaii mission and have been inspired by the legacy of Ellison Onizuka and his contribution to the aerospace industry.

During the Legislative Session of 2013, the budget was amended to appropriate 5.0 FTE in EDN 100 and \$248,656 in general funds in BED 128 Office of Aerospace. These amendments are found on page 121 and 205 of the Legislative Budget Worksheets:
