<u>DEPARTMENT'S POSITION</u>: The Department of Human Services (DHS) supports this administration measure.

<u>PURPOSE</u>: The purpose of the bill establishes the Hawaii State Fusion Center (Center) as a program under the Office of Homeland Security as described in chapter 128A, Hawaii Revised Statutes. Also establishes the position of Hawaii State Fusion Center Director who shall be state-funded, permanently exempt from chapter 76, Hawaii Revised Statutes, responsible to the Director of Homeland Security, and accountable to manage the operations of the Center.

The Fusion Center and the Fusion Center Director are vital to the security, health, and well-being of Hawaii's residents and visitors. The Fusion Center provides access to cross-sector and cross-government communication.

DHS is a partner agency with the Fusion Center, and DHS staff actively participate in training and briefings that are easily accessible and available on a variety of issues. In the past

year, DHS staff have attended training and discussions addressing cyber security, efforts of online law enforcement to identify sex trafficking, active shooter events, coronavirus procedures, and debriefs of significant events to inform planning.

In January 2020, shortly after news of the coronavirus was emerging from China, DHS staff attended a presentation at the Fusion Center by the CDC Honolulu Region Division of Global Migration and Quarantine on CDC's procedures. Throughout the pandemic, the Fusion Center has continued to provide pandemic related resources and awareness, and other security information and advice leading up to the 2020 election and the violent January 6, 2021 insurrection at the U.S. Capitol.

I am MG Kenneth S. Hara, Adjutant General, Director of Emergency Management and Homeland Security Advisor. Thank you for the opportunity to submit testimony in **SUPPORT** of HB 957.

The proposal of HB 957, with the additions to HRS Chapter 128A will solidify the Hawaii State Fusion Center. One of the major functions of the fusion center is to share information ensuring our partners are equipped with the necessary tools to keep Hawaii and the Nation safe, secure and resilient.

The Hawaii State Fusion Center serves as a focal point for the state for the receipt, analysis, gathering and sharing of threat-related information between the federal, state, local, and private sector partners. Fusion centers are situated in the state to empower front line law enforcement, public safety, fire, emergency responders, public health, critical infrastructure protection and private sector security personnel to understand the implications of intelligence for and to the State. The fusion center provides interdisciplinary expertise and situational awareness to inform decision-making at all levels of government. The Hawaii State Fusion Center conducts analysis and facilitates information sharing by assisting law enforcement and homeland security partners in preventing, protecting against and responding to crime, terrorism and all-hazard incidents.

The fusion center collaborates among all levels of government to receive, analyze, and disseminate threat related information in coordination with intelligence partners by coordinating with the 16 critical infrastructure sectors and lifelines, for example, electric, water, food, gas, utilities, communications, etc.

The collaboration includes the integration of cyber related threat information, cyber-crime prevention and analytic capabilities to assist in identifying cyber threats and indicators to individual networks and systems.

The intelligence analysts within the fusion center assist piecing together the disparate bits of information to form integrated views to produce actionable intelligence products on emerging cyber incidents, risk, threats, event, or trend.

The Hawaii State Fusion Center works closely with all educational levels and security personnel to track certain school incidents, such as stranger-danger or threats of targeted school violence. In addition, the Hawaii State Fusion Center works with members of the visitor industry and with retail establishments to help them track threats against visitors and businesses.

The Hawaii State Fusion Center is an important part of Hawaii's Homeland Security and the protection of our citizens and visitors.

Coordinated and timely dissemination of information —including the integrated analysis of threat trends and events, the identification of knowledge gaps, and the ability to collaboratively mitigate adversary threats—builds the solid platform from which our islands can be best protected.

As a utility and essential service provider, Hawaii Gas has long been a partner company to the Hawaii State Fusion Center. The Fusion Center provides numerous resources and relationships across both the government and private sector, fostering collaboration with critical infrastructure partners and government entities such as DHS, FBI, HPD, DOD, and others. Through the Fusion Center, we receive regular updates on current and potential threats, particularly in the cybersecurity arena, and routine briefings by various organizations on their work to keep Hawaii safe.



As even greater threats loom on the horizon —from cyber security to infectious diseases to domestic terrorism —we welcome the opportunity to enhance the state's homeland security through the enhanced position and authority of the State Fusion Center as established by this proposal.

We urge the committees to pass HB 957.

The information that we receive from the Hawaii State Fusion Center is invaluable through their dissemination of information on leads, tips, trends, suspicious activities and more. It is only by continuing to work in partnership that we can maintain a Hawaii that is not only safe to visit but to live and work as well.

As the former Under Secretary for Intelligence at the Department of Homeland Security, I had the pleasure of visiting Hawaii in November 2019 to meet with Governor Ige and co-host the Domestic Security Alliance-Corporate Security Symposium. We spoke about the importance of State Fusion Centers to coordinate and drive intelligence sharing for federal, state, local, and private sector partners. As the current Chief Executive Officer for the National Insurance Crime Bureau (NICB), I am fortunate to lead a national, century-old, not-for-profit organization supported by approximately 1,200 property and casualty insurance companies, including many who write business in Hawaii. Working hand-in-hand with our member companies and law enforcement, we investigate organized criminal conspiracies dealing with insurance and vehicle crime.

When it comes to criminals, one thing is certain: they will stop at nothing to hurt, steal, and defraud. Collating various intelligence sources is critical toward identifying and anticipating risks and emerging threats and staying one step ahead of the bad actors.

For this reason, the NICB supports HB 957 which will create a state fusion center to:

- 1. Create a focal point for sharing local, national, and international information and context with the national level intelligence community.
- 2. Collaborate among all levels of government on threat-related information in coordination with multi-disciplinary partners.
- 3. Establish a joint integration center to, among other things, combat cybercrime and cyberterrorism.

The NICB thanks you for your review and consideration and looks forward to working with and being of value to a future state fusion center.
